#### A PROCLAMATION

REVOKING A PROCLAMATION, DATED THE 31ST DAY OF MAY, 1955, DECLARING THE EXISTENCE OF A STATE OF EMERGENCY FOR THE PURPOSES OF THE EMERGENCY POWERS ACT, 1920.

Whereas by virtue of Our Proclamation, dated the Thirty-first day of May, nineteen-hundred and fifty-five, We did declare the existence of a state of emergency for the purposes of the Emergency Powers Act, 1920:

And Whereas it appears to Us that the state of emergency has now ceased to exist, and that it is expedient that the said Proclamation should be revoked accordingly:

Now, therefore, We, by and with the advice of Our Privy Council, do hereby proclaim, direct and ordain that the said Proclamation of the Thirty-first day of May, nineteen-hundred and fifty-five, is revoked.

Given at Our Court at Buckingham Palace, this twenty-first day of June, in the year of our Lord one thousand nine-hundred and fifty-five, and in the Fourth year of Our Reign.

WHEREAS the Secretary of State for Scotland has in pursuance of the powers competent to him under the Burial Grounds (Scotland) Act, 1855, made a Representation that Grounds (Scotland) Act, 1855, made a Representation that he has received a copy of an Interlocutor dated 31st March 1955, pronounced by the Sheriff Substitute of Inverness, Moray, Nairn and Ross and Cromarty at Inverness, finding that the Burial Ground known as Skeabost (or South Snizort) Old Cemetery, on the Island of Skye, in the Parish of Snizort and County of Inverness is in a condition which is dangerous to health and contrary to decency:

And Whereas in the said Representation it is recommended that in terms of Section 5 of the aforesaid Act burials be forthwith discontinued in the said Burial Ground except for the burial of:—

except for the burial of:

- (1) the remains of any person which the County Council of Inverness have specially authorised to be buried in the said Burial Ground; and
  - (2) cremated human remains;

Provided that-

- (a) the excercise of the right of burial be not injurious or offensive or contrary to decency;
- (b) intimation of a burial be given to the District Sanitary Inspector of the County of Inverness not later than the day preceding that on which a grave is to be opened;
- (c) no burial be made which will interfere with a coffin in an adjoining lair; and
- (d) no burial except the burial of cremated human remains shall be made unless the coffin can be laid at a depth of four feet from the surface level of the ground to the upper surface of the coffin and that without interference with the remains of a previous burial.

Now, therefore, Her Majesty is pleased, by and with the advice of Her Privy Council to give Notice of the said Representation and to order that the same be taken into consideration on the 10th day of August next:

And Her Majesty is further pleased to direct that this Order, or notice thereof, be published in the Edinburgh Gazette and that copies of this Order, or notice thereof, be fixed as required by the said Act on the doors of the church of, or on some other conspicuous places within the Parish of Snizort, one month before such Representation is so considered. sidered.

REGULATIONS FOR THE RECRUITMENT OF ARCHITECTURAL AND ENGINEERING DRAUGHTSMEN.

#### 1. Age.

Candidates must be at least 20 on 1st June 1955. There is no upper age limit, but in appointing persons in a permanent capacity Departments expect regular and effective service for a reasonable period, and the Commissioners will take this requirement into account.

- 2. Sex and Marriage.
- (i) Both men and women may compete under these Regulations.
- (ii) Married women who have formerly been established civil servants and have drawn marriage gratuity (other than those who resigned compulsorily on marriage and whose resignation took effect before 15th October 1946, or who are resignation took effect before 15th October 1946, or who are widowed or divorced, or who are separated from their husbands, or whose husbands suffer without hope of recovery from total physical or mental incapacity) will not be eligible unless they undertake to refund on appointment the marriage gratuity paid.
