The Lords Commissioners of Her Majesty's Treasury hereby give notice that They have made an Order under Sections 1 and 19 of the Import Duties Act 1932, Section 10 of the Finance Act, 1934, and Section 1 of the Import Duties (Emergency Provisions) Act, 1939.
viz:—

The Import Duties (Exemptions) (No. 9) Order, 1955. Siloxanes, whether polymerised or not, and certain mixtures containing 50 per cent. or more by weight of siloxanes are exempt from duty chargeable under the Import Duties Act, 1932.

This Order extends the exemption to cover all such mixtures, and comes into operation on the 29th September, 1955. It has been published as Statutory Instruments 1955, No. 1473.

TENDERS FOR TREASURY BILLS.

1. Notification will be sent by post on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part, and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday, 11.30 a.m.) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

**DANGEROUS DRUGS ACT, 1951.
WITHDRAWAL OF AUTHORISATION
(CONRAD SPENCER WHITEHOUSE)**

WHEREAS Conrad Spencer Whitehouse, M.B., M.R.C.S., whose registered address is 11 Handsworth New Road, Birmingham, 18, has been convicted of offences against the Dangerous Drugs Act, 1951:

And Whereas the said Conrad Spencer Whitehouse cannot in my opinion properly be allowed to be in possession of or to supply any drug or preparation to which the Dangerous Drugs Regulations, 1953, apply:

Now Therefore, in pursuance of the powers conferred on me by Regulation 29 of the Dangerous Drugs Regulations, 1953, I hereby withdraw from the said Conrad Spencer Whitehouse the authorisation conferred by the said Regulations upon him to be in possession of and to supply the drugs or preparations to which the Dangerous Drugs Regulations, 1953, apply:

And I hereby direct that it shall not be lawful for the said Conrad Spencer Whitehouse to give prescriptions for the purposes of the Dangerous Drugs Regulations, 1953.

Civil Service Commission, 23rd September, 1955.

The Civil Service Commissioners give notice that an Open Competition for recruitment to the Senior Branch of the Foreign Service will be held, the written examination beginning on 5th January, 1956, under the regulations dated the 7th September, 1954, and published in the *London Gazette* of the same date, amended as follows:—

The Tuberculosis (Area Eradication) Amendment Order, 1955

(Made 14th September, 1955)

This Order amends the Tuberculosis (Area Eradication) Order, 1950 which applies to every area declared by Order to be an Eradication Area or Attested Area for purposes connected with the control of bovine tuberculosis. The

Order of 1950 contains a provision that no bovine animal shall be moved into an Attested Area except under the authority of a licence. The amending Order, which comes into operation on 1st October, 1955, makes an exception from this restriction in the case of a movement into an Attested Area from an adjoining Attested Area by a route wholly within those two Attested Areas.
