#### WAGES COUNCILS ACTS, 1945 to 1948

RETAIL BREAD AND FLOUR CONFECTIONERY TRADES WAGES COUNCIL (SCOTLAND)

The Retail Bread and Flour Confectionery Trades Wages The Retail Bread and Flour Confectionery Trades Wages Council (Scotland) hereby gives notice of its intention to submit to the Minister of Labour and National Service proposals to (1) increase the statutory minimum remuneration set out in the Bread and Flour Confectionery Trades Wages Council (Scotland) Wages Regulation Order, 1955 (Order B.F.C.S. #### Civil Service Commission, 3rd January, 1956.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of H.M. Treasury, viz.:—

REGULATIONS FOR RECRUITMENT TO THE EXECUTIVE CLASSES (GENERAL AND DEPARTMENTAL EXECUTIVE CLASSES OF THE HOME CIVIL SERVICE AND GRADE 5 POSTS IN BRANCH B OF THE FOREIGN SERVICE).

Candidates must be at least 171 and under 19 years of age (a half-year equals six calendar months) on the governing date.

For an examination held in the first six months of any year the governing date for age will be the 1st March in that year; for an examination held in the last six months of any year it will be the 1st September in that year.

#### 2. Sex and Marriage.

- (i) Both men and women are eligible, but women will not ordinarily be appointed to posts in the Admiralty or War Office or to the Immigration Service of the Home Office.
- (ii) Married women are not eligible for appointment to Branch B of the Foreign Service. A woman member of Branch B of the Foreign Service must resign her appointment on marriage.
- (iii) The approval of the Secretary of State for Foreign Affairs is required before a successful male candidate who is married takes up appointment in Branch B of the Foreign Service.

#### 3. Nationality.

Candidates must be British subjects. They must also satisfy one of the following conditions:—

- (a) If natural-born British subjects, they must either
- (i) have at least one parent who is or was at death a British subject; or
- (ii) have resided in Her Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.
- (b) If naturalised British subjects, they must have resided in Her Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.
- (c) If not qualified under (a) or (b) of this paragraph they must satisfy the Commissioners that they are so closely connected with Her Majesty's dominions either by ancestry, upbringing or residence, or by reason of national service, that an exception may properly be made in their favour.

For the Foreign Service every candidate must be a natural-born British subject, and have been born within the United Kingdom or one of the self-governing Dominions, of parents both of whom were also born within the United Kingdom or one of the self-governing Dominions.

No departure from this rule will be made without the special permission of the Secretary of State for Foreign Affairs, and then only in exceptional cases, and in favour of candidates who satisfy the conditions laid down above for the Home Civil Service.

#### 4. Health and Character.

Successful candidates must satisfy the Civil Service Commissioners as to their health and character.

#### 5. Examination.

(a) The written examination, which must be taken by all candidates, consists of:

A candidate may take three optional subjects; but a candidate who takes Pure and Applied Mathematics may not take either Pure Mathematics or Applied Mathematics; and a candidate who takes Biology may not take either Botany or Zoology. A candidate taking history may take two papers only in this subject.

Candidates who wish to be assigned to Branch B of the

Foreign Service must take at least one of the languages in subjects 7 to 12 and reach a satisfactory standard in it; and those who wish to be assigned to the post of Actuarial Assistant in the Government Actuary's Department must take Pure Mathematics and reach a satisfactory standard

- (b) The candidates who are highest in order of merit in the written examination, down to a level to be determined by the Commissioners, will be declared successful immediately on the result of that examination.
- (c) Of the candidates next in order of merit in the written examination, a certain number, to be determined by the Commissioners, will be summoned to interview, as part of the examination. The maximum mark for this interview will be 300. Posts available which have not been filled under (b) will be filled by those candidates who are highest in order of merit on their combined marks for written examination and interview, provided enough candidates reach an acceptable standard.

#### 6. Candidates Trained as Teachers.

Candidates who have been trained as teachers and upon whose training public money has been spent cannot be appointed until the consent of the appropriate central education authority (e.g., the Ministry of Education, the Scottish Education Department, the Ministry of Education for Northern Ireland) has been notified to the Commissioners.

#### 7. Assignment.

The Commissioners will decide to which Service or Depart-The Commissioners will decide to which Service of Department each successful candidate is to be assigned. Candidates declared successful under Regulation 5 (b) on the written examination will be summoned to an interview in London shortly after their results are notified to them. This interview will be to help the Commissioners to assign them to Services and Departments. Candidates who are interviewed as part of the examination, under Regulation 5 (c), will not normally be required to attend for further interview. The Commissioners however reserve the right to summon any candidate to a second interview if this seems to them necessary.

The wishes expressed by successful candidates at interview, or on the preference form which they will be required to fill up, will so far as possible be taken into account; but assignments must be made so as to fill the vacancies notified assignments in the commissioners in accordance with the needs of the public service. A candidate who declines to accept the post offered will have no claim to be assigned to another, and will be regarded as having declined appointment.

An application fee of 7s. 6d. is payable by all candidates. This must be sent with the application form, and is not returnable in any circumstances. A further fee of 7s. 6d. being the balance of the prescribed fee of 15s., must be paid by each candidate on admission to the examination.

The Civil Service Commissioners further give notice that an Open Competition will be held under the above Regulations, the written examination commencing on 17th April, 1956.

No person will be admitted to the Competition from whom the Secretary of the Civil Service Commission has not received, on or before the 16th February, 1956, an application on the prescribed form which may be obtained from the Secretary at once.
