PRESENT,

The QUEEN's Most Excellent Majesty in Council.

WHEREAS by section 3 of the Naval and Marine Pay and Pensions Act, 1865 (28 & 29 Vict. c. 73), it is enacted that all pay, wages, pensions, bounty money, grants or other allowances in the nature thereof payable in respect of services in Her Majesty's naval or marine force to a person being or having been an officer, seaman or marine, or to the widow or any relative of a deceased officer, seaman or marine, shall be paid in such manner, and subject to such restrictions, conditions and provisions, as are from time to time directed by Order in Council:

And whereas Her Majesty deems it expedient to make further provision concerning retired pay, pensions and other grants for officers, nurses and ratings disabled in consequence of service during the 1914 World War:

Now, therefore, Her Majesty, in exercise of the powers conferred upon Her as aforesaid and of all other powers whatsoever Her thereunto enabling, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:—

The Order in Council dated the 29th September, 1949, relating to officers, nurses and ratings as therein defined, as amended by the Orders in Council dated the 28th October, 1949, the 31st March, 1950, the 31st May, 1951, the 29th April, 1952, the 18th July, 1952, the 28th May, 1953, the 5th January, 1955, and the 29th June, 1956, shall be further amended in the respects set out in the following Articles of this Order in Council, which shall be construed as one with the said Order of the 29th September, 1949, as so amended.

1. For Article 5A (*See Order in Council of 31st May, 1951*) there shall be substituted the following Article:—

"5A. *Allowances for comforts.*—(1) An officer, nurse or rating in receipt of retired pay or a pension may be awarded an allowance for the provision of comforts—

(a) at the rate of £52 a year in the case of an officer or nurse or 20s. a week in the case of a rating where the degree of the pensioned disablement is 100 per cent., and the officer, nurse or rating is in receipt of an allowance for constant attendance and is also either in receipt of an allowance under Article 5 of this Order or a person not in receipt of such an allowance whose retired pay or pension has been awarded in respect of multiple injuries which, in the opinion of the Minister, render his disablement so severe as to justify the award of an allowance at the aforementioned rate;

(b) at the rate of £26 a year in the case of an officer or nurse or 10s. a week in the case of a rating if he does not qualify for an award under subparagraph (a) of this paragraph but is in receipt of an allowance for constant attendance or an allowance under Article 5 of this Order.

(2) For the purposes of this Article—

(a) the expression "retired pay" includes wounds pension under the Regulations in force before the 4th August, 1914, retired pay at the half-pay rate under proviso (1) (a) (iii) to Article 1 of the 1921 (Officers) Order and alternative retired pay under Article 3 of the 1921 (Officers) Order and Article 3 of the 1921 (Warrant Officers) Order; and the expression "pension," in relation to a nurse, includes an alternative pension under Article 23c of the 1921 (Officers) Order, and, in relation to a rating an alternative pension under Article 3 of the 1920 Order;

(b) the expression "an allowance for constant attendance" means an allowance awarded under Article 7 or 27 of the 1921 (Officers) Order, Article 7 of the 1921 (Warrant Officers) Order or Article 6a of the 1920 Order;

(c) an officer, nurse or rating who would be in receipt of an allowance for constant attendance if he were not in a hospital or other institution shall be deemed to be in receipt of such an allowance."

2. In the proviso to Article 10, as amended (See Order in Council of 31st May, 1951), (which provides for the award of allowances for part-time treatment) for the words and figures "Article 5 (2), 5A, 12 or 19" there shall be substituted the words and figures "Article 5 (2), 5A, 12, 12A (1), or 19."

3. After Article 12, there shall be inserted the following Article:—

"12A. *Age allowances.*—(1) Except where paragraph (2) of this Article applies, an officer, nurse or rating who is in receipt of retired pay or a pension in respect of disablement the degree of which is 40 per cent. or over may, if he has attained the age of 65 years, be awarded an allowance in accordance with the following Table—

(2) Where an officer, nurse or rating has attained the age of 65 years and is receiving approved treatment or is a person to whom Article 9 of this Order applies, he may be awarded an allowance—

(a) if the degree of his pensioned disablement is 40 per cent. or over, at the rate appropriate to the degree of that disablement in accordance with the Table in paragraph (1) of this Article or at such higher rate as the Minister may determine having regard to the circumstances of the case; or

(b) if, in the opinion of the Minister, an award should be made in any other case, at such rate as the Minister may determine:

Provided that the rate of any allowance under this paragraph shall not exceed £39 a year in the case of an officer or nurse or 15s. a week in the case of a rating.

(3) For the purposes of this Article, the expression "retired pay" includes wounds pension under the Regulations in force before the 4th August, 1914, retired pay at the half-pay rate under proviso (1) (a) (iii) to Article 1 of the 1921 (Officers) Order and alternative retired pay under Article 3 of the 1921 (Officers) Order and Article 3 of the 1921 (Warrant Officers) Order; and the expression "pension," in relation to a nurse, includes an alternative pension under Article 23c of the 1921 (Officers) Order, and, in relation to a rating, an alternative pension under Article 3 of the 1920 Order."

4. This Order shall come into operation in relation to an officer or nurse on the 1st February, 1957, and in relation to a rating on the 6th February, 1957.

EXPLANATORY NOTE

(This Note is not part of the Order, but is intended to indicate its general purport).

1. This Order amends the Order of the 29th September, 1949, as amended by subsequent Orders.

2. The existing rates of allowances for comforts are increased from £26 a year in the case of an officer or nurse and 10s. a week in the case of a rating to £52 a year and 20s. a week respectively.

Allowances of £26 a year in the case of officers and nurses and of 10s. a week in the case of ratings may now be awarded for the provision of comforts for certain severely disabled pensioners who are in receipt of either the Unemployment Supplement or a Constant Attendance Allowance. (Article 1).

3. An allowance ranging from £13 a year to £39 a year in

the case of an officer or nurse and from 5s. a week to 15s. a week in the case of a rating is introduced for pensioners who have attained the age of 65 years and whose pensioned disablement is assessed at 40 per cent. or over. (Article 3).

WHEREAS by section 3 of the Naval and Marine Pay and Pensions Act, 1865 (28 & 29 Vict. c. 73), it is enacted that all pay, wages, pensions, bounty money, grants or other allowances in the nature thereof payable in respect of services in Her Majesty's naval or marine force to a person being or having been an officer, seaman or marine, or to the widow or any relative of a deceased officer, seaman or marine, shall be paid in such manner and subject to such restrictions, conditions and provisions, as are from time to time directed by Order in Council:

And whereas Her Majesty deems it expedient to amend the Order concerning retired pay, pensions and other grants in cases where the disablement or death of members of the naval forces is due to service after the 2nd September, 1939:

Now, therefore, Her Majesty, in exercise of the powers conferred upon Her as aforesaid and of all other powers whatsoever Her thereunto enabling, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:—

The Order in Council dated the 29th September, 1949, relating to members of the naval forces as therein defined, as amended by the Orders in Council of the 28th October, 1949, of the 31st May, 1951, of the 29th April, 1952, of the 18th July, 1952, of the 28th May, 1953, of the 5th January, 1955, and of the 29th June, 1956, shall be further amended in the respects set out in the following Articles of this Order which shall be construed as one with the said Order of the 29th September, 1949, as so amended.

1. For Article 17A (See Order in Council of 31st May, 1951) there shall be substituted the following Article:—

"17A. *Allowances for comforts.*—(1) A member of the naval forces in receipt of retired pay or a pension under Article 11 may be awarded an allowance for the provision of comforts—

(a) at the rate of £52 a year in the case of an officer or 20s. a week in the case of a rating, where the member, the degree of whose pensioned disablement is 100 per cent., is in receipt of an allowance under Article 15 and is also either in receipt of an allowance under Article 17 or a person not in receipt of such an allowance whose retired pay or pension has been awarded in respect of multiple injuries which, in the opinion of the Minister, render his disablement so severe as to justify the award of an allowance at the aforementioned rate;

(b) at the rate of £26 a year in the case of an officer or 10s. a week in the case of a rating if he does not qualify for an award under subparagraph (a) of this paragraph but is in receipt of an allowance under Article 15 or under Article 17.

(2) For the purposes of this Article, a member who would be in receipt of an allowance under Article 15 if he were not in a hospital or other institution shall be deemed to be in receipt of an allowance under that Article."

2. After Article 18 there shall be inserted the following Article:—

"18A. *Age allowances.*—Where a member of the naval forces who is in receipt of retired pay or pension under Article 11, in respect of disablement the degree of which is 40 per cent. or over, has attained the age of 65 years, he may be awarded an allowance in accordance with the following Table:—

3. In Article 20 (which provides for the award of treat-

ment allowances) there shall be inserted, after paragraph (2), the following paragraph:—

“(2A) Where the member has attained the age of 65 years, he may be awarded an increase of the allowance under paragraph (2) of this Article—

(a) at a rate equal to that of the allowance which he would be receiving under Article 18A but for proviso (b) to paragraph (1) of this Article or at such higher rate as the Minister may determine having regard to the circumstances of the case; or

(b) at such rate as the Minister may determine if in his opinion an award should be made to a person who is not eligible for an award under the preceding subparagraph:

Provided that the rate of any increase under this paragraph shall not exceed £39 a year in the case of an officer or 15s. a week in the case of a rating.”

4. In Article 22 (which provides for the award of allowances for part-time treatment) for the words and figures “Article 14, 15, 16, 17 (2) or 17A” in the proviso, as amended (See Order in Council of 31st May, 1951), there shall be substituted the words and figures “Article 14, 15, 16, 17 (2), 17A or 18A” and, after the words and figures “under Article 20” there shall be inserted the words “(excluding any award under paragraph (2A) of that Article).”

5. This Order shall come into operation in relation to an officer on the 1st February, 1957, and in relation to a rating on the 6th February, 1957.

EXPLANATORY NOTE.

(This Note is not part of the Order, but is intended to indicate its general purport).

1. This Order amends the Order of the 29th September, 1949, as amended by subsequent Orders.

TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday, the 1st February, 1957, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £190,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday, the 4th February, 1957, to Saturday, the 9th February, 1957, inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent by post on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part, and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday, 11.30 a.m.) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

Civil Service Commission, 25th January, 1957.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of H.M. Treasury, viz.:—

REGULATIONS FOR THE LIMITED COMPETITION FOR RECRUITMENT TO THE ADMINISTRATIVE CLASS OF THE HOME CIVIL SERVICE.

1. Both men and women are eligible, but women will not ordinarily be appointed to posts in the Ministry of Defence, Admiralty, War Office, or Air Ministry.

2. No candidate may compete in more than two Limited Competitions for the Administrative Class; but competing under both Method I and Method II in the same year will be treated as a single attempt.

3. Age.

Candidates must be at least 21 and under 28 years of age on 1st August, 1957.

Provided that the Commissioners may at their discretion waive the upper age limit in favour of a candidate who

(a) has been employed by his Department overseas; or

(b) was, although eligible, prevented from attending an earlier examination as a result of his having been recalled from the Reserve for a period of service or training with H.M. Forces; and has thereby been deprived of one of the two attempts which he might normally have made.

(It is expected that these concessions will apply in future Limited Competitions.)

4. Service.

Candidates must have had at least two years' service immediately before 1st August, 1957, in either

(a) an established situation in the Home Civil Service to which they were admitted with a certificate of the Civil Service Commissioners. Service on established

conditions of service except for sick leave and pension may count towards the whole or part of this period in the case of candidates who on medical grounds were not accepted for fully established appointment or were told by the Commissioners that a decision on health had been deferred; or

(b) a situation in the Office of the Commissioner of Police of the Metropolis, the Office of the Receiver for the Metropolitan Police District, the Office of the Crown Agents for Oversea Governments and Administrations, the Foreign Compensation Commission, the Forestry Commission, the Nature Conservancy, or Trinity House, after having been appointed to a post in one of those Offices as a result of a competition held by the Civil Service Commissioners.

Periods of service in the Armed Forces (other than periods covered by annual leave or by the grant of special leave with pay) may reckon towards the two-year period. Civil servants who have been established under a scheme in which established conditions of service reckon from a common date earlier than the date of issue of the certificate of qualification may reckon towards the two-year period any service actually rendered in a non-industrial capacity after the common date and before the issue of the certificate of qualification.

5. METHOD I.

(i) The competition consists of the following:—

(A) A written examination in

(a) three compulsory subjects, Essay, English, and Present Day, each with a maximum of 100 marks;

(b) a selection from the optional subjects set out in the Appendix. Subject to the provisions in the Appendix candidates may take optional subjects up to a total of 700 marks (making 1,000 marks in all for the written examination).

(B) Interview, for candidates whose marks in the written examination give them a chance of success:—

(a) a preliminary interview by a single interviewer, who will make a report to the Final Interview Board;

(b) an interview before the Final Interview Board, which will award a mark out of a maximum of 300 for the candidate's record, intelligence, and personal qualities. The Board will not be informed of marks given in the written examination.

(ii) The final order of merit will be determined by the total marks in the whole competition. The Commissioners' decision will be final.

6. METHOD II.

(i) The competition consists of the following:—

(a) A written examination comprising an Essay, English, Present Day, a General Paper, and an intelligence test, each with a maximum of 100 marks (making 500 marks in all).

(b) A series of tests and interviews at the Civil Service Selection Board.

(c) An interview before the Final Selection Board.

(ii) Candidates who reach a qualifying standard in the written examination under (i) (A) will be invited to the Civil Service Selection Board. Of those who fail narrowly to reach this standard, the Commissioners may select for the Civil Service Selection Board a number whose records and reports give evidence of strong claims to further consideration.

(iii) The Commissioners will subsequently select in the light of the candidates' performances at the Civil Service Selection Board and of their records those who will be admitted to interview by the Final Selection Board.

(iv) The final order of merit will be determined by the mark awarded by the Final Selection Board. This will take into account the candidate's record, as well as his intellectual and personal qualities as shown throughout the Competition. The Commissioners' decision will be final.

(v) The Commissioners may exempt from the written examination a candidate who has previously obtained good marks for it, or for the compulsory papers in the Method I examination, and in the same competition has also been awarded a mark of more than 200 by the Final Board. The previous competition must have been a recent open or limited competition for the Administrative Class or Senior Branch of the Foreign Service.

7. Health and Character.

Successful candidates must satisfy the Commissioners on their health and character.

8. Assignment.

The Commissioners will decide to which Department each successful candidate is to be assigned; this will normally be a different Department from that in which he has been serving. Assignments will be made in accordance with the needs of the public service, but the wishes of candidates will, where possible, be taken into account.

9. Fees.

The total fee payable by all candidates is £4 for either Method separately or £6 for both Methods. Of this, £2 must be paid on application and the balance on admission to the examination. (Candidates exempted from the Method II written examination must pay the balance of the total fee when called upon to do so). Candidates who are eligible for the Open Competition for the Administrative Class may compete in that competition (by either or both methods) in the same year as they compete in the Limited Competition. But those who do so will be required to pay two separate fees in the manner prescribed for each competition, except that a candidate who competes by Method I in the Open Competition and pays the fee prescribed will not be required to pay any further fee for a concurrent candidature by Method I in the Limited Competition.
