The Import Duties (Drawback) (No. 13) Order 1957

The Import Duties (Drawback) (No. 5) Order, 1956, provided for the allowance of drawback of Customs duty paid on corks and wooden tops, when bottle stoppers incorporating both these articles were exported. The effect of the present Order is to extend that provision so as to enable drawback of customs duty paid on corks to be allowed also on the export of bottle stoppers comprising corks and non-wooden tops.

The Order comes into operation on the 23rd August, 1957, and has been published as Statutory Instruments 1957, No. 1481.

#### TENDERS FOR TREASURY BILLS.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of H.M. Treasury, viz.:—

REGULATIONS FOR THE RECRUITMENT OF OFFICERS OF CUSTOMS AND EXCISE 4N THE CUSTOMS AND EXCISE DEPARTMENT.

- 1. Men only are eligible.
- 2. No candidate may compete more than twice for the situation of Officer of Customs and Excise.

#### 3. Age.

Candidates must be at least 19 and under 22 years of age on 1st September, 1957, but—

(a) a candidate who has served or is serving in H.M. Forces may deduct from his actual age the period of such service rendered before 1st September, 1957;

(b) a candidate who has served in any established post to which he was admitted with the Certificate of the Civil Service Commissioners may deduct from his actual age any time not exceeding two years which he has spent in such service before 1st September, 1957.

#### 4. Nationality.

To be eligible for appointment a candidate must be a British subject, a British protected person or a citizen of the Irish Republic and in addition satisfy one of the following conditions:—

- (a) if he was a British subject, a British protected person or a citizen of the Irish Republic at birth—
  - (i) at least one of his parents must be, or have been at death, a British subject, a British protected person or a citizen of the Irish Republic, or

(c) if not qualified under sub-paragraph (a) or sub-paragraph (b) of this paragraph, he must satisfy the Commissioners that he is so closely connected with a country or territory within the Commonwealth either by ancestry, upbringing or residence, or by reason of national service, that an exception may properly be made in his favour.

#### 5. Health and Character.

Successful candidates must satisfy the Civil Service Commissioners on their health and character.

The interview will be held after the written examination. Of the candidates who obtain the highest total of marks in the written examination a certain number, to be determined by the Civil Service Commissioners, will be summoned to interview. The final order of merit will be determined by the total of the marks obtained in the written examination and in the interview. Candidates must obtain such a total of marks in the competition as a whole as to satisfy the Civil Service Commissioners. Even if there are unfilled vacancies, no candidate will be appointed who does not reach a standard which satisfies the Commissioners. The Commissioners' decision will be final.

#### 1. Candidates Trained as Teachers.

RECULATIONS FOR THE RECRUITMENT OF ASSISTANT EXAMINERS IN THE BANKRUPTCY AND COMPANIES (OFFICIAL RECEIVERS) SERVICE OF THE BOARD OF TRADE.

1. Both men and women are eligible.

#### 2. Age

Candidates must be at least 20 and under 28 years of age on 1st September, 1957. But a candidate who has served or is serving in H.M. Forces may deduct from his actual see any period of such service rendered before 1st September, 1957.

#### 3. Refund of Marriage Gratuity.

Married women who have formerly been established civil terrants and have drawn marriage gratuity (other than those the resigned compulsorily on marriage and whose resigna-

tion took effect before 15th October, 1946, or who are widowed or divorced, or who are separated from their husbands, or whose husbands suffer without hope of recovery from total physical or mental incapacity) will not be eligible unless they undertake to refund on appointment the marriage gratuity paid. #### 6. Scheme of Examination.

Part I-Written Examination.

Use of English and legibility of handwriting will be taken into account throughout the examination.

(a) English—Candidates will be required to write an essay and to summarise a passage. Other questions will be set to test understanding and command of language.

Candidates will be expected to keep closely to the subject of the essay, to arrange their ideas in orderly fashion, and to work concisely; effective and exact expression will be rewarded. The summary will be marked for its accuracy and for the understanding and use of English which it shows. A limit may be set for the number of words which the summary should contain; to use more than the stated number will entail loss of marks. It is useful for candidates to have some idea of the number of words they are accustomed to write on an unruled foolscap page.

(b) Book-keeping and Accounts, with special reference to partnerships and limited companies.

#### (c) General Commercial Knowledge.

(d) Commercial and Company Law, including the rights and duties of liquidators, receivers, trustees in bankruptcy, and trustees under deeds of arrangement; Income Tax law. This paper will be divided into three sections, and candidates will be obliged to answer some questions from each; they are advised to consult the published specimen question paper.

Exemption from the written examination will be granted to those who by 19th September, 1957, have passed any of the following:—

The Intermediate Examination of the Institute of Chartered Accountants in England and Wales or of the Institute of Chartered Accountants of Scotland or of the Institute of Chartered Accountants in Ireland or of the Association of Certified and Corporate Accountants or of the Society of Incorporated Accountants; the Final Examination of the Chartered Institute of Secretaries or of the Corporation of Secretaries.

Part II-Interview.

Of those who obtain the highest total of marks in the written examination, a certain number, to be determined by the Commissioners, together with those granted exemption from the written examination will be invited to an interview before a Selection Board. The Board will take into account the candidates' personal qualities and experience, their performance in the written examination or the nature of their exempting qualifications, and their technical knowledge as shown at the interview. The Board will recommend to the Commissioners for appointment those candidates who appear to them to be most suitable: even if there are unfilled vacancies no candidate will be recommended who does not reach a standard which satisfies the Commissioners. The Commissioners' decision will be final.

#### 7. Candidates Trained as Teachers.
