The Import Duties (Drawback) (No. 17) Order, 1957, which reduces from 1s. 11d. to 1s. 0d. per lb. the rate of drawback allowable in respect of Customs duty paid on unblown hatters' fur used in the manufacture of exported hats, bonnets, etc.; and increase from 1% to 1.49 lb. the quantity of fur to be taken into account in calculating the amount of drawback allowable in respect of each pound of felt contained in the exported goods.
