"Section IV.

"Special Capital Payments in Addition to Service Retired Pay or Service Gratuities for Permanent Officers.

- "8. Any Officer prematurely retired from the Active List after 4th April, 1957, and granted retired pay pension or a Service gratuity under Sections I or III of this Schedule may be awarded a special capital payment in addition to his retired pay pension or gratuity under the following conditions:
 - (a) An Officer can qualify only once for a grant.
 - (b) The grant will be free of Income Tax.
 - (c) These payments will be based on the paid rank held at the time of retirement whether this be acting temporary or substantive.
 - "9. The scale of the grant will be as follows:
