THE Secretary of State has received the following letter from the Boundary Commission for Scotland:—

23rd November, 1959.

#### Sir,

1. As you know, the Boundary Commission for Scotland are empowered by section 2(3) of the House of Commons (Redistribution of Seats) Act, 1949, from time to time to submit to the Secretary of State reports with respect to the area comprised in any constituency or constituencies, showing the constituencies into which they recommend that that area should be divided in order to give effect to the rules set out in the Second Schedule to that Act as amended by the House of Commons (Redistribution of Seats) Act, 1958.

2. As a result of recent boundary changes, the following burghs have come to be situated partly in a burgh constituency and partly in the adjoining county constituency:

- (1) Dunfermline is partly in Dunfermline Burghs and partly in West Fife;
- (2) Greenock is partly in Greenock burgh constituency and partly in West Renfrewshire; and

Midlothian to the city of Edinburgh, the recommendations the Commission have in mind are based on the assumption that the principle indicated in rule 4(1)(b) required that, so fa as is placticable, no part of a county of a city shall be included in a constituency other than one of the burgh constituencies into which that city is divided.

In terms of section 2(4) of the Redistribution of Seats Act, 1949, the Commission give notice that they intend to make a report under section 2(3) showing with respect to the areas included in the aforesaid county and burgh con tituencies, the constituencies into which they recommend that such areas should be divided. The purpose of the recommendations related to the recent boundary changes in Dunfermline, Greenock and Musselburgh is to bring the position in the areas concerned into compliance with the provisions of rule 4(1) (b) of the Second Schedule to the 1949 Act, which rule requires that in Scotland, so far as is practicable, no burgh other than a county of a city shall be included partly in one constituency and partly in another.
