DANGEROUS DRUGS REGULATIONS, 1953 SUSPENSION OF WITHDRAWAL OF AUTHORITIES

(WILLIAM DAVID THOMPSON)

WHEREAS the authorities conferred by the Dangerous Drugs Regulations, 1953, on WILLIAM DAVID THOMP-SON, M.B., B.Ch., by virtue of his being a duly qualified medical practitioner to be in possession of and to supply the drugs and preparations to which those Regulations apply were, the said William David Thompson having been convicted of offences against the Dangerous Drugs Act, 1951, withdrawn in pursuance of the powers conferred on the Secretary of State by Regulation 29 of the aforesaid Regulations by Notices published in the London Gazette and the Edinburgh Gazette on the 30th day of November 1956, the registered address of the said William David Thompson being then Chalfont, Haverfordwest, Pembrokeshire:
