STOPPING UP OF HIGHWAYS IN THE CITY OF ABERDEEN

The draft order applies the provisions of that Act, with modifications, to those tidal waters specified in paragraph 1 of the Second Schedule to the Act, viz.:

The tidal waters of the Firth of Clyde (including the waters of Holy Loch, Loch Goil, Loch Long and Gareloch) to the north and east of an imaginary line drawn across the Firth of Clyde in a westerly direction from Cloch Point in the County of Renfrew to Castle Hill, Dunoon, in the County of Argyll and of any stream flowing into those waters.

The modifications provide that the Act should not apply so as to restrict the ordinary use of sanitary appliances in vessels within the tidal waters.
