TENDERS FOR TREASURY BILLS

1. Notification will be sent by post on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday, 11.30 a.m.) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

The Import Duty Drawbacks (No. 1) Order, 1962.

DEPARTMENT OF AGRICULTURE AND FISHERIES FOR SCOTLAND  
IMPORTATION OF RAW VEGETABLES

THE Secretary of State for Scotland has made an Order relaxing the restrictions on the landing in Scotland for prescribed periods in 1962 of certain raw vegetables grown in specified districts in Belgium, France, Italy and the Netherlands.

The Order, which comes into operation on March 1st, is a seasonal one, and provides for alternative safeguards against Colorado beetle to those set out in the Importation of Plants (Scotland) Order, 1955.
