TRUNK ROADS ACT, 1946 SPECIAL ROADS ACT, 1949 DUNEATON DIVERSION IMPROVEMENTS

THE Secretary of State gives notice that he proposes to make an Order under section 14 of the Special Roads Act, 1949, as read with the Transfer of Functions (Roads, Bridges and Ferries) Order, 1955, to provide for (a) the construction by the Secretary of State of a new road near Duneaton in Lanarkshire, to provide an improved junction of the existing London-Carlisle-Glasgow-Inverness Trunk Road (A. 74) with the new trunk road which he proposes to construct, (b) the stopping up of two lengths of the said existing trunk road when the new road and the proposed new trunk road are opened for the purposes of through traffic and (c) Lanark County Council becoming the highway authority for the new road on the date on which notice is given by the Secretary of State to the Council that the new road is opened for through traffic.

SCHEDULE

As from 30th March 1962 the Order would impose unilateral waiting on High Street, Cowdenbeath between 8 a.m. and 6 p.m. Mondays to Saturdays inclusive, on the odd and even date system with waiting limited to 30 minutes in any hour on that side of the road on which vehicles would not be prohibited from waiting for the time being.

FACTORIES ACTS 1937 to 1959

IN pursuance of section 129 of, and the Second Schedule to, the Factories Act, 1937, the Minister of Labour hereby gives notice that he proposes to make special regulations imposing requirements for the safety, health and welfare of persons employed in the melting or founding of non-ferrous metals. The regulations will revoke the Regulations, dated 20th June 1908, with respect to the casting of brass.
