DUNEATON DIVERSION IMPROVEMENTS

THE Secretary of State gives notice that he has made the London-Carlisle-Glasgow-Inverness Trunk Road (Duneaton Diversion Improvements) Order, under section 14 of the Special Roads Act, 1949 as read with the Transfer of Functions (Roads, Bridges and Ferries) Order 1955, which trunk road Order provides for (a) the construction by the Secretary of State of a new road near Duneaton in Lanarkshire to provide an improved junction of the existing London-Carlise-Glasgow-Inverness Trunk Road (A.74) with the new trunk road which he proposes to construct, (b) the stopping up of two lengths of the said existing trunk road when the new road and the proposed new trunk road are opened for the purposes of through traffic and (c) Lanark County Council becoming the highway authority for the new road on the date when the Secretary of State notifies the Council that the new road is opened for through traffic.

FACTORIES ACT 1961
