*Imposition of 40 m.p.h. Speed Limit at Cumbernauld,
Dunbarton*

THE Secretary of State hereby gives notice that he proposes to make an Order under section 26 of the Road Traffic Act, 1960, the effect of which will be that a speed limit of 40 m.p.h. will be imposed on vehicles using that length of the Abington-Lanark-Airdrie-Cumbernauld Trunk Road (Route A.73) at Cumbernauld in the County of Dunbarton which extends from a point 55 yards or thereby south of its junction with the Gretna-Stranraer-Glasgow-Stirling Trunk Road (Route A.80) to a point 33 yards or thereby south of its junction with Lenziemill Road, a total distance of 2877 yards or thereby.

TENDERS FOR TREASURY BILLS

(being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

Notification will be sent by post on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday, 11.30 a.m.) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.
