TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office at the Bank of England, on Friday, the 26th October 1962, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £240,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday, the 29th October 1962, to Saturday, the 3rd November 1962, inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent by post on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday, 11.30 a.m.) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

CITY AND ROYAL BURGH OF DUNFERMLINE

ONE-WAY TRAFFIC, UNILATERAL WAITING AND PROHIBITION OF WAITING ORDER, 1962

THE Town Council of the City and Royal Burgh of Dunfermline, in exercise of the powers contained in Sub-sections (1), (2) and (3) of Section 26, and in Sub-section 4) of Section 27 of, and in Paragraph (13) of the 19th Schedule to the Road Traffic Act, 1960, and of all other powers enabling them in that behalf hereby 1) revoke the Byelaws for the Regulation of Traffic (Unilateral Waiting and One-Way Traffic Scheme) made and enacted by the Magistrates of the said City and Royal Burgh on the Seventeenth day of August Nineteen hundred and fifty, and confirmed by the Secretary of State on the Thirteenth day of November Nineteen hundred and fifty-one, with modifications, and as subsequently amended by said Magistrates on the Eighteenth day of December Nineteen hundred and fifty-six, and confirmed by the Secretary of State on the Eighth day of November Nineteen hundred and fifty-seven, and (2) make the following Order:

1. This Order may be cited as the "City of Dunfermline One-Way Traffic, Unilateral Waiting and Prohibition of Waiting Order, 1962" and shall come into operation on the Fourth day of November, 1962.

2. The Interpretation Act, 1889, shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

3. Except upon the direction or with the permission of a Police Constable in uniform, no person shall drive, or cause, or permit to be driven any vehicle on any of the lengths of road specified in the First Column hereunder otherwise than in the direction specified opposite to such length in the Second Column hereunder.

4. Save as provided in Article Six of this Order no person shall, except upon the direction or with the permission of a Police Constable in uniform, cause or permit any vehicle to wait in any of the lengths of road specified in the First Column hereunder:

- (a) on the side of the road specified opposite that length of road in the Second Column hereunder on those days of the month which bear even numbers, or
- (b) On the side of the road specified opposite that length of road in the Third Column hereunder on those days of the month which bear odd numbers.

5. Save as provided in Article Six of this Order no person shall, except upon the direction or with the permission of a Police Constable in uniform, cause or permit any vehicle to wait in any of the lengths of road specified in the First Column hereunder on the side thereof specified opposite thereto in the Second Column hereunder:

Randolph Street: Whole length of the street: i.e., from junction with High Street to junction with Queen Anne Street.	West Side
Queen Anne Street: From junction with Randolph Street to junction with Bruce Street, i.e., section formerly known as "Rotten Row."	South Side
Guildhall Street: Whole length of the street: i.e., from junction with High Street to junction with Abbot Street and Canmore Street.	East Side
Abbot Street: Whole length of the street: i.e., from junction with Guildhall Street and St. Margaret Street to junction with Maygate.	North Side

6. Nothing in Articles Four and Five of this Order shall prevent any person from causing or permitting a vehicle to wait in any of the lengths of road specified therein on either side of the road for so long as may be necessary:

- (a) to enable a person to board or alight from the vehicle;
- (b) to enable goods to be loaded on to or unloaded from vehicle; or
- (c) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the lengths of road so specified, or the laying, erection, alteration or repair in or near to any of the lengths of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telegraphic line as defined in the Telegraph Act, 1878.
- (d) to enable a Funeral Director or other owner of funeral vehicles to use said vehicles as part of a Funeral Cortège or otherwise in connection with a Funeral.

7. The restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any Regulations made under the Road Traffic Acts, 1930 to 1960, or by or under any other Enactment.
