STOPPING UP OF HIGHWAYS AT CAMBUSLANG, LANARKSHIRE

SPECIAL ROADS ACT 1949 THE HARTHILL BYPASS SPECIAL ROAD

CLEAN AIR ACT, 1956 GLASGOW CRAIGTON SMOKE CONTROL AREA ORDER, 1962

- 1. NOTICE is hereby given that the Corporation of the City of Glasgow in exercise of the powers conferred on them by section 11 of the above mentioned Act on the Twentieth day of December 1962 made an order entitled "The Glasgow Craigton Smoke Control Area Order, 1962" declaring the area described in the schedule hereto to be a smoke control area, which Order is about to be submitted to the Secretary of State for Scotland for confirmation.
- 2. Subject to the exemptions provided by the Order and by virtue of section 11(4) of the Act, if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels are: anthracite and semi-anthracite, briquetted fuels carbonised in the course of manufacture, coke, electricity, gas, low temperature carbonisation fuels and low volatile steam coals.
