THE Lords Commissioners of Her Majesty's Treasury hereby give notice that They have made an Order under Schedule 2 to the Finance Act 1957, viz: The Composite Goods Order 1963.

This Order revokes and replaces the Composite Goods Order, 1962.

In the case of imported composite goods containing hydrocarbon oil as an ingredient, this Order continues the provisions of the 1962 Order for duty to be charged in respect of that oil at average rates, and for certain composite goods to be treated as not containing oil, or as consisting wholly of oil. The average rate of duty remains at 5½ per cent. ad valorem generally in respect of the composite goods described in the schedule to the Order but is increased to 10½ per cent. for certain of those goods, namely, solutions of alkyd resins incorporating vegetable oils or their fatty acids or both.

The provisions of the 1962 Order relating to duties on composite goods containing sugar, invert sugar, glucose, cocoa, coffee or chicory, have ceased to have effect and have not been replaced.

MERCHANDISE MARKS ACT, 1926 Marking of Imported Ball or Roller Bearings

THE Board of Trade announce that, in pursuance of the powers conferred on them by Section 3 of the Merchandise Marks Act 1926, they have given a Direction, namely, the Merchandise Marks (Imported Goods) No. 4 Order 1928 (Provisional Exemption) No. 2 Direction 1963, in regard to the Merchandise Marks (Imported Goods) No. 4 Order 1928, as amended.

The Direction exempts imported ball or roller bearings with an outside diameter of over 12.7 mm. and not over 25.4 mm. from having to bear an indication of origin as prescribed by the Order, and permits the indication to be

printed or stamped on the wrapper or container in which the bearings are imported, sold or exposed for sale, as the case may be. Copies of the Direction (S.I. 1963 No. 1445) can be obtained from H.M. Stationery Office, and branches, orthrough any bookseller, price 3d. (by post $5\frac{1}{2}$ d.).

The Direction affords temporary relief only. TRUNK ROADS ACT 1946 SPECIAL ROADS ACT 1949

New Road between West of Harthill and West of Newhouse

THE Secretary of State gives notice that he proposes to make the following scheme and order:

- 1. A scheme under sections 1, 2 and 9 of the Special Roads Act 1949, as read with the Transfer of Functions (Roads, Bridges and Ferries) Order 1955, the effect of which will be—

 - (a) that a road which he proposes to construct to link the western terminal point of the said special road with the Edinburgh-Glasgow Trunk Road near Newhouse Industrial Estate in the County of Lanark will become a trunk road on the date when the order comes into operation; and
 - (b) the length of trunk road to be superseded by the special road and the new trunk road will cease to be a trunk road on the 16th May next after the date on which notice is given by the Secretary of State to the Lanark County Council (who will thereafter become the highway authority responsible for the length) that the said special road and the new trunk road are opened for through traffic.

Improvements from North Inchmichael to Longforgan,
Perthshire
