The QUEEN's Most Excellent Majesty in Council

Whereas by section 3 of the Naval and Marine Pay and Pensions Act 1865, 28 & 29 Vict. c. 73, it is enacted that all pay, wages, pensions, bounty money, grants or other allowances in the nature thereof payable in respect of services in Her Majesty's naval or marine force to a person being or having been an officer, seaman or marine, or to the widow or any relative of a deceased officer, seaman or marine, shall be paid in such manner and subject to such restrictions, conditions and provisions, as are from time to time directed by Order in Council:

And whereas Her Majesty deems it expedient to amend certain Orders in Council concerning retired pay, pensions and other grants for officers, nurses and ratings disabled, and for the widows and children of officers and ratings deceased, in consequence of service during the 1914 World War:

Now, therefore, Her Majesty, in exercise of the powers conferred upon Her as aforesaid and of all other powers whatsoever Her thereunto enabling, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

1. In this Order the following expressions have the meanings hereby respectively assigned to them:

- (1) "the 1920 Order" means the Order in Council of 11th June 1920, S.R. & O. 1920/1021 (II, p. 295), relating to seamen and marines, as amended by any subsequent Order in Council;
- (2) "the 1921 (Officers) Order," means the Order in Council of 9th March 1921, S.R. & O. 1921/360 (p. 770), relating to commissioned and subordinate officers and nurses, as amended by any subsequent Order in Council;

- (3) "the 1921 (Warrant Officers) Order" means the Order in Council of 9th March 1921, S.R. & O. 1921/361 (p. 794), relating to Commissioned Officers from Warrant Rank and Warrant Officers, as amended by any subsequent Order in Council;
- (4) "the 1949 Order" means the Order in Council of 29th September 1949, as amended by any subsequent Order in Council.

2. For Article 12 of the 1920 Order, as amended (Order of 20th February 1963), (allowances for the children of ratings' widows) there shall be substituted the following Article:

"12. A widow pensioned under Article 11 of this Order may be granted an allowance at the rate of 41s. 6d. a week for each child under the age of 16 years so long as the child is maintained by her; and the provisions of Article 2(3) of this Order shall apply to an allowance under this Article as they apply to an allowance under that Article."

3. In Article 12(1) of the 1921 (Officers) Order, as amended (Order of 20th February 1963), (allowances for the children of officers' widows) for the figures £96 10s. there shall be substituted the figures £116.

4. In Article 12(1) of the 1921 (Warrant Officers) Order, as amended (Order of 20th February 1963), for the figures £90 10s. there shall be substituted the figures £110.

5. In Article 14(2) of the 1949 Order, as amended (Order of 20th February 1963) (awards to widows and children on the death of officers or ratings on or after 3rd September 1939) in paragraph (c) of the proviso for the figures 40s. 6d. there shall be substituted the figures 41s. 6d.

6. In Article 15 of the 1949 Order, as amended (Order of 20th February 1963) (awards to children of officers and ratings who died before 3rd September 1939):

- (a) in paragraph (1), for the figures £96 10s. and £90 10s. there shall be substituted the figures £116 and £110 respectively;
- (b) in paragraph (3), for the figures 34s. there shall be substituted the figures 41s. 6d.;
- (c) in paragraph (4), for the figures 40s. 6d. there shall be substituted the figures 41s. 6d.

7. This Order shall be construed as one with the 1920 Order, the 1921 (Officers) Order, the 1921 (Warrant Officers) Order and the 1949 Order and shall come into operation on 30th March 1964 so, however, that in relation to any award payable weekly the foregoing reference to 30th March 1964, where this is not the normal weekly pay day for that award, shall be construed as a reference to the first normal weekly pay day for that award following 30th March 1964.

#### EXPLANATORY NOTE

(This Note is not part of the Order, but is intended to indicate its general purport).

1. This Order amends the Orders of 11th June 1920, 9th March 1921 and 29th September 1949, as amended by subsequent Orders.

2. The rates of pensions and allowances payable to or in respect of the children of deceased members of the naval forces are increased in the case of children of officers from £96 10s. or £90 10s. a year to £116 or £110 a year, and in the case of children of ratings from 34s. a week or, for motherless children under the age of 15 years, 40s. 6d. a week to 41s. 6d. a week.

Now, therefore, Her Majesty, in exercise of the powers conferred upon Her as aforesaid and of all other powers whatsoever Her thereto enabling, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

The Order in Council dated 29th September 1949, relating to members of the naval forces as therein defined, shall be further amended in the respects set out in the following Articles of this Order.

1. In Article 32, as amended (Order of 20th February 1963), (allowances in respect of children under the age limit)—

- (a) in paragraphs (2) and (3), for the figures £96 10s., £90 10s. and 34s. there shall be substituted the figures £116, £110 and 41s. 6d. respectively;
- (b) in paragraph (5) (iii), for the words and figures from "40s. 6d. a week" to the end of the paragraph there shall be substituted the words and figures "if the child has attained the age of 15 years, 54s. a week."

2. In Article 33, as amended (Order of 20th February 1963), (pensions to motherless or fatherless children under the age limit) for the figures 40s. 6d. there shall be substituted the figures 41s. 6d.

3. This Order shall be construed as one with the Order in Council of 29th September 1949, as amended by any subsequent Order, and shall come into operation on 30th March 1964 so, however, that in relation to any award payable weekly the foregoing reference to 30th March 1964, where this is not the normal weekly pay day for that award, shall be construed as a reference to the first normal weekly pay day for that award following 30th March 1964.

#### EXPLANATORY NOTE

(This Note is not part of the Order, but is intended to indicate its general purport).

1. This Order amends the Order of 29th September 1949, as amended by subsequent Orders.

2. The rates of pensions and allowances payable to or in respect of children of deceased members of the naval forces are increased in the case of children of officers from £96 10s. a year to £116 a year, in the case of children of Commissioned Officers (Branch List) and Warrant Officers from £90 10s. a year to £110 a year, and in the case of children of ratings from 34s. a week or, for motherless children under the age of 15 years, 40s. 6d. a week to 41s. 6d. a week.

#### MERCHANDISE MARKS ACT 1926

##### Marking of imported electric incandescent lamps

THE Board of Trade announce that in pursuance of the powers conferred on them by Section 3 of the Merchandise Marks Act 1926 they have given a Direction, namely, the Merchandise Marks (Imported Goods) No. 2 Order 1928 (Provisional Exemption) Direction 1964 in regard to the Merchandise Marks (Imported Goods) No. 2 Order 1928, as amended.

The Direction exempts imported electric incandescent lamps of the following description from having to bear an indication of origin as prescribed by the Order and permits the indication to be (i) indelibly stamped, embossed, incised or impressed on the cap of the lamp and (ii) indelibly marked on the carton, wrapper or other container in which the lamp is imported, sold or exposed for sale, as the case may be:

Electric incandescent projection lamps having a glass bulb, the external surface of which is coated with an obscuring finish except for a clear area for light emission.

The Direction affords temporary relief only. The question whether the Order should be amended in accordance with the terms of the Direction or otherwise is being referred to the Standing Committee appointed by the Board of Trade under Section 4 of the Merchandise Marks Act 1926.

Importation of Raw Vegetables

THE Secretary of State for Scotland has made an Order relaxing the restrictions on the landing in Scotland for prescribed periods in 1964 of certain raw vegetables grown in specified districts in Belgium, France, Italy and the Netherlands.

The Order which comes into operation on March 1st, is a seasonal one, and provides for alternative safeguards against Colorado beetle to those set out in the Importation of Plants (Scotland) Order, 1955.

Barcaldine and Other Diversions

THE Secretary of State gives notice that he proposes to make the following orders:

1.
