RATES OF INTEREST ON LOANS FROM THE LOCAL LOANS FUND

NOTICE

THE Treasury hereby give notice that, in pursuance of the powers conferred on them by the Public Works Loans Act 1964, the following rates of interest shall be charged on loans made out of the Local Loans Fund on the security of local rates on and after 1st April 1964.

The amount which an authority borrows within its annual quota will bear interest at the appropriate rate in the lower set of rates. Where authorities borrow further sums these will attract interest at the appropriate rate in the higher set of rates, unless the Public Works Loan Commissioners agree that they should be offset against the following year's quota. Different rates of interest apply according to whether the principal of a loan is repaid by way of half-yearly payments (A) or at maturity (M).

STOPPING UP OF HIGHWAYS AT FASLANE, DUNBARTONSHIRE

CLEAN AIR ACT, 1956

*The County of Midlothian (Livingston New Town
Designated Area No. 1)*

Smoke Control Area Order, 1964

1. NOTICE Is Hereby Given that the County Council of the County of Midlothian in exercise of the powers conferred on them by Section 11 of the Clean Air Act, 1956, on the Eleventh day of March Nineteen Hundred and Sixty-four made an Order entitled "The County of Midlothian (Livingston New Town Designated Area No. 1) Smoke Control Area Order, 1964" declaring the area described in the schedule hereto to be a Smoke Control Area which Order is about to be submitted to the Secretary of State for Scotland for confirmation.

2. Subject to the exemptions provided by the Order and by virtue of Section 11(4) of the Act, if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the Smoke Control Area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding Ten pounds unless he proves that the emission of smoke was not caused by the use of any fuel other than authorised fuel. The authorised fuels are: anthracite and semi-anthracite, briquetted fuels carbonised in the process of manufacture, coke, electricity, gas, low temperature carbonisation fuels and low volatile steam coals.

3. Copies of the Order and of the map referred to therein may be inspected free of charge at the offices of the County Council of the County of Midlothian, George IV Bridge, Edinburgh; at the office of the County Sanitary Inspector, 32 Palmerston Place, Edinburgh; and at the offices of the Scottish Home and Health Department, St. Andrew's House, Edinburgh, at all reasonable times during the period of six weeks from the Twenty-seventh day of March Nineteen Hundred and Sixty-four.

4. Within the said period any person who will be affected by the Order may by notice in writing to the Secretary, Scottish Home and Health Department, St. Andrew's House, Edinburgh, object to the confirmation of the Order.
