

# STOPPING UP OF HIGHWAYS IN EDINBURGH

THE Secretary of State for Scotland hereby gives notice that he intends to make an Order under section 46 of the Town and Country Planning (Scotland) Act, 1947, as read with the Transfer of Functions (Roads, Bridges and Ferries) Order, 1955, entitled the Stopping Up of Highways (City of Edinburgh) (No. 3) Order, 1964, authorising the stopping up of various streets in the Citadel and Central Leith Comprehensive Development Area, Edinburgh.

# TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday the 15th May 1964 at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £230,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Tuesday the 19th May 1964 to Saturday the 23rd May 1964, inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates. This Order was laid before the House of Commons on 8th May 1964, and is subject to Affirmative Resolution. The Order brings "imitation patent leather" within the scope of Tariff Heading 41.08. This implements a "corrigendum" to the Brussels Nomenclature issued by the Customs Co-operation Council in Brussels designed to align the French and English texts of the Heading.

The Order accordingly introduces a new sub-heading for "imitation patent leather" within the new Tariff Heading 41.08. The rates of duty applicable thereto are 20% (full), free (Commonwealth preference) and 3% (E.F.T.A.) ad valorem. The provisions of the Order become effective on 13th May 1964.

Hitherto imports of imitation patent leather have been classified under Headings in Tariff Chapter No. 41 other than 41.08, according to the type of leather to which the "patent-type" surface was applied. In practice, nearly all known imports have been classified under Tariff subheading 41.02 (A) the rates of duty currently applicable to this sub-heading being 20% (full), free (Commonwealth preference) and 8% (E.F.T.A.) ad valorem.

The Order therefore effectively maintains the existing full and Commonwealth preference rates of duty on "imitation patent leather" but reduces the E.F.T.A. rate applicable thereto from 8% to 3% ad valorem, which is the E.F.T.A. rate of duty applicable to " patent leather."

Certain E.F.T.A. products which had, in the earlier part of the E.F.T.A. transitional period (i.e., since 1st January"" 1960), been admitted as "patent leather" at the lower "patent leather" rate of duty, were subsequently classified as "imitation patent leather" chargeable at a higher rate of duty. In these circumstances and as both rates of duty will become "nil" by the end of 1966 under the present timetable for the elimination of duties between E.F.T.A. countries, it has been decided to redlee the E.F.T.A. rate of duty on "imitation patent leather" forthwith to the level of the current E.F.T.A. rate of duty on "patent leather," namely 3% ad valorem. This Order gives effect to this decision.
