TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday, the 10th September 1965, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £220,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday the 13th September 1965, to Saturday the 18th September 1965, inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent by post on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. (Saturday 11 a.m.) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

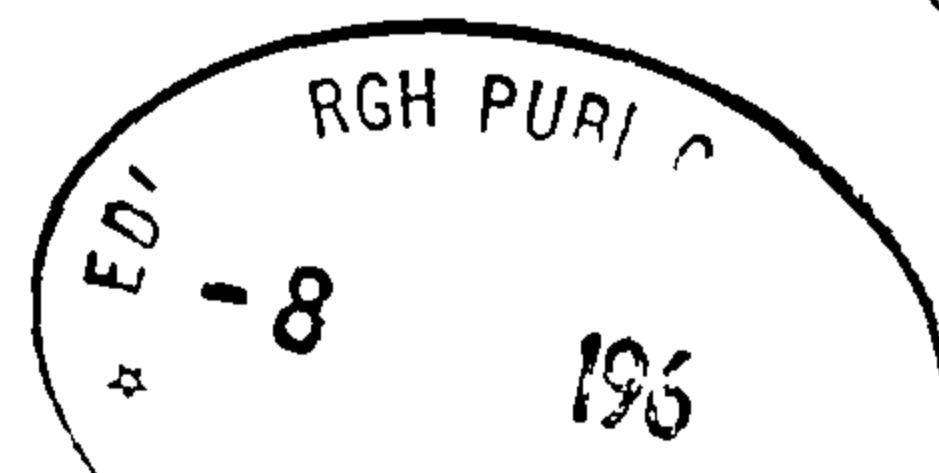

THE EDINBURGH (MURRAYFIELD—CRAMOND
No. 1) SMOKE CONTROL AREA ORDER 1965

1. NOTICE is hereby given that Edinburgh Corporation in exercise of the powers conferred on them by Section 11 of the above-mentioned Act on the Twenty-ninth day of July 1965, made an Order entitled The Edinburgh (Murrayfield-Cramond No. 1) Smoke Control Area Order, 1965, declaring the area described in the schedule hereto to be a Smoke Control Area, which Order is about to be submitted to the Secretary of State for Scotland for confirmation.

2. Subject to the exemptions provided by the Order and by virtue of Section 11(4) of the Act if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the Smoke Control Area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels are: anthracite and semi-anthracite, briquetted fuels carbonised in the process of manufacture (i.e., prepared smokeless fuels), coke, electricity, gas, low temperature carbonisation fuels, and low volatile steam coals.

3. Copies of the Order and of the Map referred to therein may be inspected free of charge at the office of the Chief Sanitary Inspector, Public Health Chambers, Johnston Terrace Edinburgh, at all reasonable times during the period 6th September to 18th October 1965.

4. Within the said period any person who will be affected by the Order may by Notice in writing to The Secretary, Scottish Development Department, 43 Jeffrey Street, Edinburgh 1, object to the confirmation of the Order.
