FORESTRY COMMISSIONERS

THE Forestry Commissioners hereby give notice that they have made an Order under the Destructive Insects and Pests Acts 1877 to 1927 entitled "The Importation of Forest Trees (Prohibition) (Great Britain) Order 1965."

The Order revokes The Importation of Forest Trees (Prohibition) Order 1952. It prohibits the importation (except under licence) of the same kinds of forest trees and from the same countries as those specified in the earlier Order but it also gives inspectors power to examine and take samples of imported trees and to destroy, at the expense of the importer, trees kept in contravention of the Order.

- This Order
 - (i) makes the amendments to existing drawback provisions necessitated by the reduced rates of import duty applicable from 31st December 1965 under the European Free Trade Area Convention;
 - (ii) varies the rates of drawback of import duty in respect of
 - (a) neckties, bow-ties and cravats manufactured from certain imported woven fabric,
 - (b) certain packing cases manufactured from specified imported plywood, and
 - (c) certain pigment manufactured from imported cadmium metal; and
- (iii) extends without limit of time the provision for drawback of import duty on certain rain-proof garments manufactured from certain imported woven fabric.

TRUNK ROADS ACTS 1936 and 1946

THE Secretary of State gives notice that he proposes to make the following orders:

1. A variation order under section 1(2) and section 11(4) of the Trunk Roads Act 1946, and section 13(2) of the Trunk Roads Act 1936 all as read with the Transfer of Functions (Roads, Bridges and Ferries) Order, 1955, the effect of which will be that the London-Carlisle-Glasgow-Inverness Trunk Road (Kirkpatrick and Newton Diversion) Order 1950 will be varied as follows:

A new part route will be substituted for the middle part of the route of the new trunk road which he proposes to construct bypassing Kirkpatrick-Fleming and Newton in the County of Dumfries.

2. An order under section 1(2) of the Trunk Roads Act

This Order provides that goods shall be treated for export rebate purposes as produced or manufactured in the United Kingdom—

- (i) in the generality of cases if not less than 20 per cent. of the costs of their production or manufacture is attributable to United Kingdom expenditure (certain costs being specified which are to be included in and excluded or deducted from these costs respectively for the purpose of deciding what proportion of them is so atributable), or
- (ii) in the case of wool tops if they have been combed or carded in the United Kingdom.

The Order revokes the provisions of the Export Rebates Order 1965 as to what goods shall be treated for export rebate purposes as produced or manufactured in the United Kingdom, and other extant provisions of that Order, except as respects wool tops exported before 1st October 1965 and other goods exported before 1st January 1966.
