#### STOPPING UP OF HIGHWAYS IN THE CITY OF GLASGOW

The Burnside (Remainder) and Cambuslang Smoke Control Area Order, 1966

- 1. NOTICE Is Hereby Given that the County Council of the County of Lanark in exercise of the powers conferred on them by Section 11 of the Clean Air Act, 1956 on the Sixth day of April Nineteen Hundred and Sixty-six made an Order entitled the Burnside (Remainder) and Cambuslang Smoke Control Area Order, 1966, declaring the area described in the Schedule hereto to be a Smoke Control Area which Order is about to be submitted to the Secretary of State for Scotland for confirmation.
- 2. Subject to the exemptions provided by the Order and by virtue of Section 11(4) of the Act if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the Smoke Control Area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding Ten Pounds unless he proves that the emission of smoke was not caused by the use of fuels other than authorised fuel. The authorised fuels are: anthracite and semi-anthracite, briquetted fuels carbonised in the process of manufacture, coke, electricity, gas, low temperature carbonisation fuels and low volatile steam coals.
- 3. The Order will not come into operation until at least six months after it is confirmed by the Secretary of State.
- 4. Copies of the Order and of the Map referred to therein may be inspected free of charge at the County Buildings, Hamilton and at the Area Office, Cambuslang, during office hours for a period of six weeks commencing the Sixteenth day of May Nineteen Hundred and Sixty-six.
