# **A PROCLAMATION**

REVOKING A PROCLAMATION, DATED THE 22ND DAY OF JUNE, 1966, DECLARING THE EXISTENCE OF A STATE OF EMERGENCY WITHIN THE MEANING OF THE EMERGENCY POWERS ACT 1920, AS AMENDED BY THE EMERGENCY POWERS ACT 1964.

Whereas by Our Proclamation, dated the twenty-second day of June, nineteen hundred and sixty-six, We declared that the stoppage of work among merchant seamen did, in Our opinion, constitute a state of emergency within the meaning of the Emergency Powers Act 1920, as amended by the Emergency Powers Act 1964:

And whereas it appears to Us that the state of emergency has now ceased to exist and that it is expedient that the said Proclamation should be revoked accordingly:

Now, therefore, We, by and with the advice of Our Privy Council, hereby proclaim that the said Proclamation is revoked.

Given at Our Court at Buckingham Palace, this fifth day of July, in the year of our Lord one thousand nine hundred and sixty-six, and in the fifteenth year of Our Reign.

The amendment of the Development Plan became operative as from the Seventh day of July 1966, but if any person aggrieved by either amendment desires to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Town and Country Planning (Scotland) Acts, 1947-63 or on the ground that any requirement of those Acts or any regulation made thereunder has not been complied with in relation to the making of either amendment, he may, within six weeks from the seventh day of July 1966 make an application to the Court of Session. 2. Subject to the exemptions provided by virtue of Section 11(4) of the Act, if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the Smoke Control Area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels are: anthracite and semi-anthracite, briquetted fuels carbonised in the process of manufacture, coke, electricity, gas, low temperature carbonisation fuels and low volatile steam coals.

3. The Order will not come into operation until at least six months after it is confirmed by the Secretary of State.

4. Copies of the Order and of the map referred to therein may be inspected free of charge at the office of the Town Clerk, Town Buildings, Port Glasgow, and at the office of the Scottish Development Department, Jeffrey Street, Edinburgh 1, at all reasonable times during the period of six weeks from the Eighth day of July 1966.

5. Within the said period any person who will be affected by the Order may, by notice in writing to the Secretary, Scottish Development Department, 43 Jeffrey Street, Edinburgh 1, object to the confirmation of the Order.
