

5. MEARNS ROAD:

From a point 15 yards south of its junction with Busby Road to Busby Road.

6. CLARKSTON TOLL ROUNDABOUT: The whole roundabout.

Excepting however from the foregoing lengths of road:

HELENA PLACE:

North Side—from the south end of No. 1 Helena Place to the north end of No. 9 Helena Place a distance of 40 yards.

EASTWOODMAINS ROAD:

North Side—from the south end of No. 149 Eastwoodmains Road to the north end of No. 145 Eastwoodmains Road a distance of 26 yards or thereby.

BUSBY ROAD:

The Order provides for exceptions to enable a vehicle to wait for as long as is necessary to enable a person to board or alight, and to enable goods to be loaded and unloaded etc., but prohibits loading or unloading on any of said lengths of road between the hours of 8 a.m. and 10 a.m. and between the hours of 4 p.m. and 6 p.m. on Mondays to Fridays and between the hours of 8 a.m. and 12 o'clock noon on Saturdays.
