ROYAL BURGH OF RUTHERGLEN

CLEAN AIR ACT 1956

The Royal Burgh of Rutherglen (Stonelaw) Smoke Control Area Order 1966

- 1. NOTICE Is Hereby Given that the Provost, Magistrates and Councillors of the Royal Burgh of Rutherglen in exercise of the powers conferred on them by section 11 of the above-mentioned Act, on the 7th day of July 1966 made an Order entitled the Royal Burgh of Rutherglen (Stonelaw) Smoke Control Area Order 1966 declaring the area described in the Schedule hereto to be a Smoke Control Area, which Order is about to be submitted to the Secretary of State for Scotland for confirmation.
- 2. Subject to the exemptions provided by virtue of section 11 (4) of the Act if, on any day after the Order has come

into operation, smoke is emitted from a chimney of any building within the Smoke Control Area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels are: anthracite and semi-anthracite, briquetted fuels carbonised in the process of manufacture, coke, electricity, gas, low temperature carbonisation fuels, and low volatile steam coals.

- 3. Copies of the Order and of the Map referred to therein may be inspected free of charge at the Council Chambers, 169 Main Street, Rutherglen at all reasonable times during the period of six weeks from 22nd day of July 1966.
- 4. Within the said period any person who will be affected by the Order may by Notice in writing to The Secretary, Scottish Development Department, St. Andrew's House, Edinburgh 1, object to the confirmation of the Order.
