WESTMINSTER-MARCH 22, 1811.

This day the Lords being met, a message was sent to the Honourable House of Commons by the Yeoman Usher of the Black Rod, acquainting them, that The Lords, authorized by virtue of his Majesty's Commission for declaring bis Royal Assent to several Acts agreed upon by both Houses, do desire the immediate attendance of the Honourable House in the House of Peers, to hear the Commission read ; and the Commons being come thither, the said Commission, empowering the Lord Archbishop of Canterbury, the Lord High Chancellor of Great Britain, and several other Lords therein named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to

An act for the regulation of his Majesty's royal marine forces while on shore.

An act for taking an account of the population of Great Britain, and of the increase or diminution thereof.

An act to amend two acts of the 13th and 32d years of his present Majesty, relating to the wages of persons employed in the silk manufacture.

And to five road and four private acts.
