TENDERS FOR TREASURY BILLS

- 1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday the 18th November 1966, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £150,000,000.
- 2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday the 21st November to Saturday the 26th November 1966, inclusive, and will be due 91 days after date.
- 3. The Bills will be issued and paid at the Bank of England.
- 4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- 5. Tenders must be made through a London Banker, Discount House or Broker.
- 6. Notification will be sent by post on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. (Saturday 11 a.m.) on the day on which the relative Bills are to be dated.
- 7. Members of the House of Commons are not precluded from tendering for these Bills.
- 8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
- 9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

Commission of Inquiry

Notice by the Commission of Inquiry appointed by the Minister of Labour to inquire into and report on the questions whether either the Hair, Bass and Fibre Wages Council (Great Britain) or the Brush and Broom Wages Council (Great Britain) or both of them should be abolished.

THE Minister of Labour (hereinafter referred to as "the Minister") is considering whether he should exercise his powers under Section 4 of the Wages Councils Act 1959 (hereinafter referred as as "the Act") to abolish the Hair, Bass and Fibre Wages Council (Great Britain) or the Brush and Broom Wages Council (Great Britain) or both of them.

In pursuance of the powers conferred upon him by Sections 6 and 9 of, and the Fourth Schedule to, the said Act, the Minister has appointed a Commission of Inquiry and has referred to it the questions whether either or both of the said Wages Councils should be abolished.

On a reference under Section 6 of the Act as to the abolition of a wages council, a Commission may make a report to the Minister in accordance with Section 6(2) of the Act.

Accordingly the Commission hereby gives notice, pursuant to Section 9 of the Act, that it will consider representations with respect to the foregoing questions which it is its duty to consider made to it in writing at the office of the Commission at Ebury Bridge House, Ebury Bridge Road, London S.W.1 within 40 days from the 15th November 1966, that is to say, before the 26th day of December 1966.

BERWICK COUNTY COUNCIL

(Turfford Burn) Flood Prevention Scheme 1966

The effects of the Order which will come into operation on 5th December 1966 will be:

- 1. To retain, with minor modifications, existing restrictions on the waiting of vehicles between the hours of 1 p.m. and 6 p.m. on Saturdays and on the waiting of vehicles for the purposes of loading or unloading between the hours of 4.30 p.m. and 6 p.m. on Saturdays.
 - (a) in the portion of Bath Street between Hope Street and North Street;
 - (b) in the portion of St. George's Road between Sauchiehall Street and Renfrew Street; and
 - (c) in the portion of Sauchiehall Street between Wood-side Crescent and Hope Street; and
- 2. To retain, with minor modifications existing restrictions on the waiting of vehicles including waiting for the purposes of loading or unloading between the hours of 1 p.m. and 6 p.m. on Saturdays in the vicinity of,
 - (a) all road junctions with Bath Street between North Street and Hope Street inclusive;

- (b) the junction of Berkeley Street and North Street;
- (c) the junction of Kent Road and North Street;
- (d) the junction of Renfrew Street and St. George's Road; and
- (e) all road junctions with Sauchiehall Street between Woodside Crescent and Hope Street inclusive.

REGULATION OF STREET PARKING PLACES IN GLASGOW
