THE Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under Sections 9 and 13 of, and Schedule 5 to, the Import Duties Act 1958, and Section 2(5) of the Finance Act 1965.

Viz.: The Import Duty Drawbacks (No. 6) Order 1967.

This Order:

- (a) provides that there shall continue to be no drawback of import duty in respect of telemetering instruments and apparatus, notwithstanding the re-classification of those goods in a tariff heading (90.28) which would otherwise render them eligible for drawback;
- (b) revokes the existing fixed rate of drawback of import duty in respect of bromvalerone manufactured from imported iso Valeric acid and provides for drawback to be related to the duty paid on the acid actually used in the manufacture of the exported goods; and
- (c) revises the rates of drawback of import duty in respect of—
 - (i) hats, etc., manufactured from imported hatters' fur, and
 - (ii) photographic film, etc., manufactured from imported film base.

This Order comes into operation on 6th July 1967, and has been published as Statutory Instruments 1967 No. 952.

THE Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under Sections 1, 2 and 13 of the Import Duties Act 1958.

Viz.: The Import Duties (General) (No. 5) Order 1967.

This Order:

- (1) amends heading 58.07 of the Customs Tariff in conformity with a corrigendum to the English text of the Brussels Nomenclature approved by the Customs Co-operation Council to make it clear that flock chenille yarn is covered by heading 58.07;
- (2) introduces a subheading for certain telemetering instruments and apparatus under heading 90.28 of the Customs Tariff. Following a Classification Opinion of the Customs Co-operation Council these goods, which were formerly classified under Chapter 85 of the Tariff at rates of duty of 16% or 17½, ad valorem, are now classifiable under heading 90.28. But for this Order, the reclassification would have raised the rate of duty to 25, ad valorem. The Order prescribes a rate of 16, ad valorem for all the goods concerned.

The Order comes into operation on 6th July 1967, and has been published as Statutory Instruments 1967 No. 953.
