TENDERS FOR TREASURY BILLS

- (1) North side of North Beach between Cromwell Street and the entrance to Cromwell Street Quay.
- (2) South side of Point Street between Castle Street and Cromwell Street.

The Burgh of Stornoway (Various Streets) (Waiting Restrictions) Order No. 2 1966, in so far as it relates to the south side of Point Street between Castle Street and Cromwell Street is amended in accordance with the provisions of this Order.

The Burgh of Stornoway (Francis Street and Cromwell Street) (Waiting Restrictions) Order 1967

No person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait between the hours of 8 a.m. and 6 p.m. in any of the following lengths of road:

- (1) North side of Francis Street between Kenneth Street and Lewis Street.
- (2) West side of Cromwell Street between Point Street and South Beach.
 - a. for a longer period than twenty minutes; or
 - b. if a period of less than twenty minutes has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicles on that side.

The Burgh of Stornoway (Point Street—North Side) (Waiting Restrictions) Order 1967

No person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait between the hours of 8 a.m. and 6 p.m. in the following lengths of road:

North side of Point Street between Castle Street and Cromwell Street,

- a. for a longer period than twenty minutes; or
- b. if a period of less than twenty minutes has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle on that side.

The Burgh of Stornoway (Various Streets) (Waiting Restrictions) Order No. 1 1966, in so far as it relates to the north side of Point Street between Castle Street and Cromwell Street is amended in accordance with the provisions of this Order.

Nothing in the forementioned Orders shall prevent any person from causing or permitting a vehicle to wait in the lengths of road referred to for so long as may be necessary: (a) for the purpose of loading or unloading goods; (b) for the picking up and setting down of passengers; and (c) for repairing public utilities or for construction or demolition purposes.
