PRICES AND INCOMES ACT 1966

Report of the National Board for Prices and Incomes

CHARGES, COSTS AND WAGES IN THE ROAD HAULAGE INDUSTRY

ON 17th August 1967, in pursuance of their powers under section 2(1) of the Prices and Incomes Act 1966, the First Secretary of State and the Ministers of Labour and Transport referred the question of Charges, Costs and Wages in the Road Haulage Industry to the National Board for Prices and Incomes for examination.

The Board has now made its report and in accordance with section 5(1) of the Prices and Incomes Act 1966 the Secretary of State for Economic Affairs, and the Ministers of Labour and Transport hereby give notice that the report was first published as Command Paper Number 3482 on 6th December 1967.

FACTORIES ACT 1961

THE Minister of Labour hereby gives notice that on 24th November 1967, he made The Baking and Sausage Making (Christmas and New Year) Order 1967, under section 117 of the Factories Act 1961. This Order enables women, who have attained the age of eighteen, to be employed in England and Wales on the afternoon of Saturdays, 9th, 16th and 30th December 1967 and on Sundays, 10th, 17th and 31st December 1967, in the manufacture of meat pies, sausages or cooked meats, or in the pre-packing of bacon; and on the afternoons of Saturdays, 9th and 16th December 1967 and on Sundays, 10th and 17th December 1967, in the manufacture of bread or flour confectionery (including fruit pies but not biscuits).

The Order also enables women, who have attained the age of eighteen, to be employed in Scotland on the afternoons of Saturdays, 16th, 23rd and 30th December 1967 and on Sundays, 17th, 24th and 31st December 1967, in the manufacture of meat pies, sausages or cooked meats, or in the pre-packing of bacon; and on Sunday, 17th December 1967, in the manufacture of bread or flour confectionery (including fruit pies but not biscuits).

Withdrawal of Authorities

NOEL PATRICK BURNS

WHEREAS Noel Patrick Burns, M.A., M.B., B.Chir.(Cantab), L.M.S.S.A., M.R.C.P.(Ed.), whose registered address is 19 Balfour Road, Acton, London W.3, is, under Regulations 4 and 10 of the Dangerous Drugs (No. 2) Regulations 1964, authorised, by virtue of being a duly qualified medical practitioner, to possess and supply drugs and other substances to which the said Regulations respectively apply so far as may be necessary for the practice or exercise of his said profession:

And Whereas the said Noel Patrick Burns has been convicted of an offence against the Dangerous Drugs Act 1965 and cannot in my opinion properly be allowed to remain a person authorised as aforesaid:

Now Therefore, in pursuance of the power conferred on me by Regulation 22 of the said Regulations, I hereby withdraw from the said Noel Patrick Burns the authorities aforesaid under the said Regulations 4 and 10:

And, in pursuance of Regulation 11 of the said Regulations, I hereby direct that it shall not be lawful for the said Noel Patrick Burns to give prescriptions prescribing any substance for the time being falling within Part I of the Schedule to the Dangerous Drugs Act 1965.

SCOTTISH HOME AND HEALTH DEPARTMENT
Public Health (Imported Food) (Scotland) Regulations, 1937 to 1948
 ITALY

THE Secretary of State gives notice in pursuance of the above-named Regulations that he hereby recognises the Official Certificate of which particulars are given in Part I of the Schedule hereto as showing (a) that the meat to which the Certificate relates or the meat from which the meat product to which it relates was prepared, was derived from animals inspected ante and post-mortem and passed in accordance with criteria satisfactory to the Secretary of State and (b) that all necessary precautions for the prevention of danger to public health were taken in the dressing or preparing of the meat or meat product.

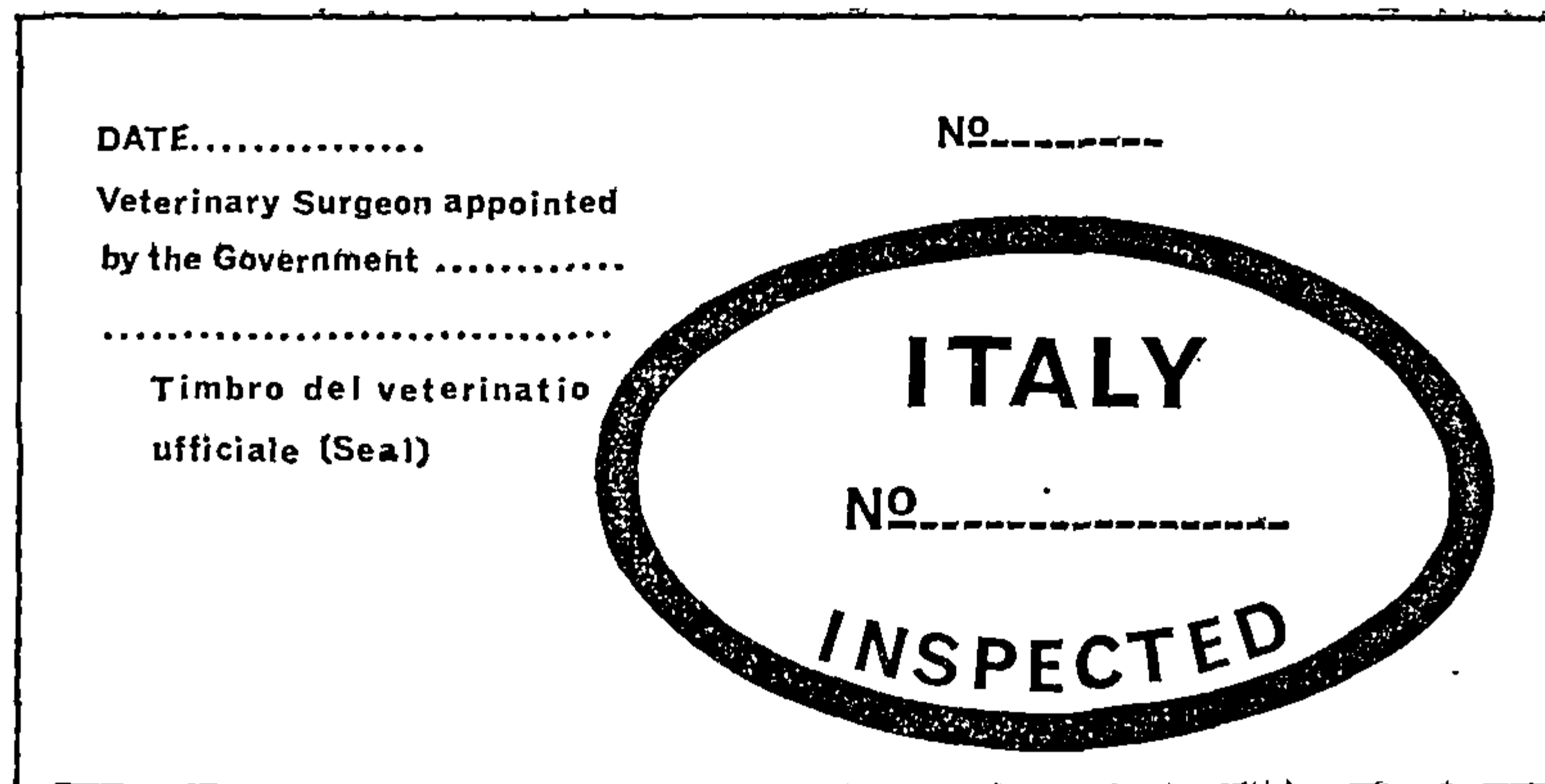
Where the Certificate is in the form of a label, recognition will apply only if the label is securely affixed to the meat or the package containing the meat or meat product and if the label has not in any other circumstances or on any other occasion been used as an Official Certificate; and where the Certificate is in the form of a stamp, recognition will apply only if the stamp is clearly impressed or otherwise marked on the meat or container as the case may be.

The Official Certificate published in the *Edinburgh Gazette* dated 28th October 1960 will continue to be recognised until 1st June 1968, from which date it is hereby revoked.

Recognition of the Official Certificates is restricted to the extent indicated in Part II of the Schedule hereto.
