Special Roads Act 1949

THE STIRLING BYPASS SPECIAL ROAD

THE Secretary of State gives notice that he proposes to make the following scheme and orders:

- 1. A scheme under sections 1, 2 and 9 of the Special Roads Act 1949, as read with the Transfer of Functions (Roads, Bridges and Ferries) Order 1955, the effect of which will be:
- (a) to provide for 4 special roads (motorways) in the Counties of Stirling and Perth on the routes prescribed by the proposed scheme for the exclusive use of traffic of Classes I and II set out in Schedule 2 to the said Act, as varied by the Special Roads (Classes of Traffic) (Scotland) Order 1964, to connect the Stirling-Callander-Crianlarich Trunk Road (A.84/A.85) with the proposed Stirling Bypass Special Road; and
- (b) to provide that the special roads become trunk roads on the date of coming into operation of the scheme.
- 2. Two orders, in relation to the Stirling Bypass Special Road, in the Counties of Stirling and Perth, under sections 3 and 7 of the Special Roads Act 1949, as read with the Transfer of Functions (Roads, Bridges and Ferries) Order 1955, and section 28(2) of the Local Government (Scotland) Act 1966, the effect of which will be to provide for:
- (a) (i) the improvement, raising, lowering or otherwise altering roads,
 - (ii) stopping up roads and constructing new roads,
 - (iii) stopping up private means of access to premises and providing new means of access, and
 - (iv) diverting watercourses
 - all on or in the vicinity of the route of the Stirling Bypass Special Road, and
- (b) the County Councils of the Counties of Stirling and Perth becoming the highway authorities for the new roads within their respective county boundaries on the 16th day of May after the date on which notice is given by the Secretary of State to the Councils that the said roads have been completed and opened for through traffic.

Copies of the draft scheme and orders, relative plans, and a statement explaining the proposals may be inspected free of charge at all reasonable hours from 14th December 1967, to 14th March 1968, at the office of the Scottish Development Department, 43 Jeffrey Street, Edinburgh 1,

and at the offices of Stirling County Council, County Offices, Viewforth, Stirling; Perth County Council, County Offices, York Place, Perth; Stirling Central No. 1 District Council, District Offices, Bannockburn; and Perth Western District Council, Commercial Bank, Dunblane.

Any Person may within three months from 14th December 1967, object to the making of the scheme or orders by notice in writing to the Secretary, Scottish Development Department, 43 Jeffrey Street, Edinburgh 1, quoting reference R/SR/4/16 and stating the grounds of objection.

Owners and tenants of property likely to be affected by the proposals may obtain an explanatory leaflet on application to the Scottish Development Department; the District Valuer, Clydesdale Bank Buildings, Corn Exchange Road, Stirling; or any of the Councils above-mentioned.

- 7. Members of the House of Commons are not precluded from tendering for these Bills.
- 8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
- 9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

PRICES AND INCOMES ACT 1966 Reference to the National Board for Prices and Incomes INCREASES IN RENTS OF LOCAL AUTHORITY HOUSING

IT is the Government's intention to do everything in their power to create the climate in which an effective prices and incomes policy can be pursued. To this end, as announced by the Prime Minister on 19th November, they have decided to refer to the National Board for Prices and Incomes certain increases in rents of local authority housing.

In their examination of the question referred to them it will be necessary for the National Board for Prices and

Incomes to take account of the statutory obligations of local authorities as regards the fixing of rents and the management of the housing revenue account. It is not intended that they should concern themselves with wider questions of housing subsidies or local government finance.

Accordingly, in pursuance of their powers under Section 2(1) of the Prices and Incomes Act 1966, the Secretary of State for Economic Affairs, the Minister of Housing and Local Government, the Secretary of State for Scotland and the Secretary of State for Wales, hereby refer to the National Board for Prices and Incomes for examination the question of the reasons for, and phasing of, increases in rents of local authority housing, with particular reference to the increases in rents by the authorities named in the schedule to this reference and to any proposed rent increases affecting tenants of the Greater London Council.

NOTICE Is Hereby Given that the above Development Plan Amendment, which contains proposals for alterations to the City of Glasgow Development Plan (hereinafter referred to as "the proposals"), was on the 11th day of December 1967 submitted to the Secretary of State for Scotland for approval. The proposals relate to the following areas of ground:
