Reference to the National Board for Prices and Incomes

DISTRIBUTORS' MARGINS IN RELATION TO MANUFACTURERS' RECOMMENDED PRICES

THE Government recognise that some increase in prices is the unavoidable consequence of devaluation. They are, however, concerned that the increases attributable to devaluation made in manufacturers' and distributors' prices should be no greater than is justified by the increase in overall costs incurred. Thus, in the Government's view, increases in distributors' prices should not provide for automatic maintenance of current percentage margins.

Certain manufacturers, however, customarily recommend prices for the resale of their goods which provide for a specific percentage margin to be taken by distributors. The Government consider it desirable that the implications of this practice being followed in cases where the manufacturer's price is increased for reasons attributable to devaluation should be urgently examined.

Accordingly, in pursuance of their powers under Section 2 (1) of the Prices and Incomes Act 1966, the Secretary of State for Economic Affairs, the President of the Board of Trade and the Minister of Agriculture, Fisheries and Food hereby refer to the National Board for Prices and Incomes for examination the question of the margins of distributors, in the event of an increase in the manufacturer's price attributable to devaluation, on those goods for which prices for resale are customarily recommended.

PAY OF NURSES AND MIDWIVES IN THE NATIONAL HEALTH SERVICE

Direction under Section 5(4) further extending the period within which the National Board for Prices and Incomes must publish their report

WHEREAS the First Secretary of State, the Secretary of State for Scotland and the Minister of Health, in pursuance of their powers under section 2(1) of the Prices and Incomes Act 1966, referred the above-mentioned question to the National Board for Prices and Incomes for examination and have published the text of the reference in the Gazette on 30th June 1967 ;

2. And whereas by section 5(3) of the Act, but subject to section 5(4), the Board are required to make their report so as to allow publication within three months of the said date ;

MERCHANDISE MARKS ACT 1926

ORIGIN MARKS ON PRE-PACKED CUTS OF IMPORTED MEAT

AN Order in Council under Section 2 of the Merchandise Marks Act, 1926 was made on the 20th December 1967, amending the Merchandise Marks (Imported Goods) No. 7 Order 1934 and comes into force on 20th March 1968.

This Order embodies the recommendations of the Standing Committee on the labelling of Pre-Packed cuts of Imported Meat and requires that all meat and edible offal when sold or exposed for sale in pre-packed form, wholesale or by retail, shall bear the required indication of origin clearly and conspicuously marked in letters of not less than $\frac{1}{8}$ th inch in height, provided that the net weight of the meat or edible offal in the container or package does not exceed 4 lb. at the time of sale, or exposure for sale. In addition, it will permit the indication of origin to appear, in the prescribed size of lettering, for all pre-packed meat on each container or package of meat.

MINISTRY OF AGRICULTURE, FISHERIES AND FOOD

DISEASES OF ANIMALS ACT 1950

NOTICE is hereby given in pursuance of Section 85(3) of the Diseases of Animals Act, 1950 that the Minister of Agriculture, Fisheries and Food has made the following Order:

(Statutory Instruments 1967 No. 1822)

The New Forest (Foot-and-Mouth Disease) Prevention Order 1967

This temporary order, made under section 1 of the Diseases of Animals Act 1950 for the prevention of the spread of foot and mouth disease into the New Forest, empowers the verderers to serve on persons having right of common of pasture over the Forest, and on others, notices requiring them to remove animals from the Forest. It also empowers the verderers to confine animals at large in the Forest, or require their confinement, in temporary enclosures in the Forest authorised by the verderers.

The order remains in force only so long as the New Forest continues to be within a controlled area for the purposes of the Foot and Mouth Disease (Controlled Areas Restrictions) General Order of 1938.

(Statutory Instruments 1967 No. 1823)

The Foot-and-Mouth Disease (Temporary Restrictions) Order 1967

This order enables the Minister of Agriculture, Fisheries and Food or the Secretary of State for Scotland by notice in writing to prohibit persons from being on agricultural or adjoining land. The appropriate Ministers must be satisfied that the presence of such a person involves a risk of spreading foot-and-mouth disease. The order specifies how notice is to be given.

Owners and occupiers of land are exempted, and the families and servants of occupiers, except where the land is owned or occupied by bodies of persons for the purpose of carrying on a sport or game. Necessary access to dwellings is preserved, and allowance is made for emergencies.

A person who knowingly contravenes a prohibition after being given notice of it commits an offence against the Diseases of Animals Act 1950 and may be punished by a fine of £50, or, on a subsequent conviction within 12 months, imprisonment for one month.

The order is a temporary one, and will expire at the end of March 1968 unless it is extended by a further order.

(Statutory Instruments 1967 No. 1839)

The Foot-and-Mouth Disease (Infected Areas Restrictions) (Amendment) Order 1967

This order, made under sections 1, 20 and 85 of the Diseases of Animals Act 1950, revokes article 14 of the Foot and Mouth Disease (Infected Areas Restrictions) Order of 1938 (under which the movement of animals through an infected area is permitted provided the animals are not untrucked).

(Statutory Instruments 1967 No. 1840)

The New Forest (Foot-and-Mouth Disease) (Prevention) Amendment Order 1967

This order, made under sections 1 and 85 of the Diseases of Animals Act 1950 extends the operation of the New Forest (Foot and Mouth Disease) (Prevention) Order 1967 so as to apply in respect of all land subject to rights or privileges of common which is within the perambulation of the New Forest.

DISEASES OF ANIMALS ACT 1950

NOTICE is hereby given in pursuance of Section 85(3) of the Diseases of Animals Act, 1950 that the Minister of Agriculture, Fisheries and Food has made the following Order:

(Statutory Instruments 1967 No. 1793)

The Importation of Carcasses and Animal Products (Amendment) (No. 2) Order, 1967

Under the importation of Carcasses and Animal Products Order 1954, as amended, a licence is required from the Minister of Agriculture, Fisheries and Food or the Secretary of State for Scotland to land carcasses and animal products in Great Britain. There are various exceptions, three of which apply to meat. The first exception enables fully cooked meat to be landed, whatever the country of origin; the

second enables all meat originating in certain countries to be landed unconditionally; and the third enables certain kinds of meat originating in named countries or parts of countries to be landed if specified conditions are complied with. This order, while it is in operation, takes away the third exception, except for fully cured bacon and ham, so that all other kinds of meat (including pig meat and offal) which could previously be landed conditionally without a licence now require one.

(Statutory Instruments 1967 No. 1805)

The Importation of Carcasses and Animal Products
(Amendment) (No. 3) Order 1967

Under the Importation of Carcasses and Animal Products Order 1954, as amended, a licence is required from the Minister of Agriculture, Fisheries and Food or the Secretary of State for Scotland to land carcasses and animal products in Great Britain. Imports from the countries named in Part I of Schedule 2 to that order are exceptions, and may be landed unconditionally. This order, by deleting the reference to the Union of South Africa from Part I of that Schedule, makes a licence necessary, except for fell-mongered goat hair and fell-mongered cow hair, which can be landed without a licence if it is accompanied by the declaration set out in Schedule 3 to the 1954 order.
