

#### PRICES AND INCOMES ACT 1966

Reference to the National Board for Prices and Incomes

#### COSTS AND PRICES OF THE CHOCOLATE AND SUGAR CONFECTIONERY INDUSTRY

THE Minister of Agriculture, Fisheries and Food has been notified under the early warning system of proposals by various manufacturers of chocolate and sugar confectionery for increases in prices. After full examination, these price increases have been accepted as justified against the criteria set out in the White Paper on Prices and Incomes Policy after 30th June 1967 (Cmnd. 3235). The Minister and the Secretary of State for Economic Affairs consider, however, that it is desirable that the National Board for Prices and Incomes should examine the structure of costs and prices of the industry with special regard to the need to finance new investment that is necessary to efficiency.

Accordingly, in pursuance of their powers under Section 2(1) of the Prices and Incomes Act 1966, the Secretary of State for Economic Affairs and the Minister of Agriculture, Fisheries and Food hereby refer to the National Board for Prices and Incomes for examination the question of the structure of costs and prices in the chocolate and sugar confectionery industry with special regard to the industry's capacity to undertake new investment.
