Ancient Monuments Consolidation and Amendment Act 1913

SPECIAL ROADS ACT 1949

The Kinross and Milnathort Bypass Special Road

THE Secretary of State has made a Scheme for a Special Road (Motorway) from a point south west of Kinnaird in Kinross-shire to a point on the Inverkeithing-Perth Trunk Road (A.90) near Blairfield. The Scheme provides for the Special Road to become a trunk road, and that it will be for use only by motorway classes of traffic.

Other proposals will be published to carry existing roads or accesses over or under the Special Road or to stop them up. Access to the Special Road will be restricted to grade-separated junctions and it is at present planned that these should be located approximately at the sites shown circled on the plan.

Copies of the Scheme, the title of which is the Kinross and Milnathort Bypass Special Road Scheme 1968, can be purchased through any bookseller or direct from Her Majesty's Stationery Office, 13a Castle Street, Edinburgh 2, price 5d.

Copies of the Scheme with plan have been deposited at the office of the Scottish Development Department, 43 Jeffrey Street, Edinburgh 1, and at the offices of Perth County Council, County Offices, Perth, and Kinross County Council, County Buildings, Kinross, and may be seen at all reasonable hours free of charge.

Any Person aggrieved by the Scheme and desiring to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the statutory powers or on the ground that any requirement of the said Act of 1949 has not been complied with in relation to the Scheme, may, within six weeks of 12th April 1968 apply to

the Court of Session for the suspension or quashing of the Scheme or of any provision contained therein.

Owners and tenants of property likely to be affected by the proposals may obtain an explanatory leaflet on application to the Department, District Valuer, Clydesdale Bank Buildings, Corn Exchange Road, Stirling, or either of the County Councils.

The Cowcaddens Compulsory Purchase Order, No. 3, 1963

WHEREAS the Secretary of State for Scotland in exercise of the powers conferred on him by the above-mentioned Acts, on the Fourteenth day of April 1965, confirmed with modifications a Compulsory Purchase Order entitled "The Cowcaddens Compulsory Purchase Order No. 3, 1963" submitted by the Corporation of the City of Glasgow:

And Whereas the Order as confirmed provides for the purchase for the purposes of Part II of the Town and Country Planning (Scotland) Act, 1947, of the land described in the first Schedule thereto:

And Whereas by a Direction given under section 42(2) of the Town and Country Planning (Scotland) Act, 1947, consideration of the Order, so far as it related to the land described in the Schedules hereto, was postponed for a period of twelve calendar months from the Fourteenth day of April 1965.

Now Therefore Take Notice that the said the Secretary of State for Scotland in exercise of the powers conferred on him by the above-mentioned Acts on the Twenty-seventh day of March 1968, confirmed the said Order in so far as it relates to the land described in the first Schedule hereto. The property at 2 McPhater Street and 55, 57 and 59/61 Port Dundas Road, owned by The Trustees of Philip Duffy and forming part of Plot No. 27 on the map referred to in the Order; the property at 57 Port Dundas Road and 63 Port Dundas Road, owned by The Glasgow Hiring Company Limited and forming part of Plot No. 27 and the whole of Plot No. 28, respectively, on the map referred to in the Order; the property at 76 Milton Street, owned by Hugh Stevenson and Sons Limited and forming the whole of Plot No. 29 on the map referred to in the Order; the property at 16 McPhater Street, owned by Ozalid (Northern) Limited and forming the whole of Plot No. 30 on the map referred to in the Order; and the property at 11, 13, 15/17, 31/37 and 41 Dunblane Street and 66/58 Milton Street, owned by John Barrie (Contractor) Limited and forming the whole of Plot No. 31 on the map referred to in the

Order have been excluded from the Order as confirmed, all as described in the second Schedule hereto.

A copy of the Order as confirmed and of the map referred to therein have been deposited at the Town Clerk's Office (Room 36), City Chambers, Glasgow, and may be seen there without payment of fee between the hours of 9 a.m. and 5 p.m., on Mondays to Fridays inclusive.

The Order as confirmed contains a Direction under Section 36 of the Town and Country Planning (Scotland) Act, 1947, that the provisions of the Sixth Schedule to the Town and Country Planning (Scotland) Act, 1945 (as amended by the Town and Country Planning (Scotland) Act, 1947, and set out in the Eleventh Schedule thereto), providing for expedited completion of purchase shall apply to the Order as respects the whole of the land comprised therein.

Any person entitled to claim compensation in respect of any of the land to which the Sixth Schedule applies or in respect of any interest in any such land, may send to the Corporation of the City of Glasgow his name and postal address, a description of the land in which he has an interest sufficient to enable them to identify the extent and boundaries thereof, and particulars of his interest in the land, of any leases and tenancy of, and any heritable securities and other real burdens and encumbrances affecting the land and of any war damage sustained by the land.

Provision as to entry on and vesting of the land is contained in Sub-paragraph (4) of paragraph 3 of the Sixth Schedule. The general effect of this provision is set out below but reference should be made to the Sixth Schedule itself for its precise operation:

- (i) The said The Corporation of the City of Glasgow shall be entitled on the expiration of the period (not being less than 28 days) specified in a declaration executed by them to enter on and take possession of the land in the area designated by the declaration without previous consent or compliance with Sections 83-88 of the Lands Clauses Consolidation (Scotland) Act, 1845. The earliest date at which such a declaration may be executed is at the expiration of a period of two months from the date of the recording of the Order in the Register of Sasines.
- (ii) On the recording of a Notice of Title in the appropriate Register of Sasines the said land shall vest in the said The Corporation of the City of Glasgow.
- (iii) The said The Corporation of the City of Glasgow will be liable to pay the like compensation and interest as would have been payable if the provisions of the 1845 Act had been complied with.

There as exceptions from the position as indicated above in the case of short tenancies and long tenancies about to expire.

The Order as confirmed becomes operative on the Fifth day of April 1968, but if application is made to the Court of Session under Paragraph 15 of the First Schedule to the Acquisition of Land (Authorisation Procedure) (Scotland) Act, 1947, within a period of six weeks from that date by any person aggrieved by the Order who desires to question the validity thereof, the Court of Session may, by interim order, suspend the operation of the Order or any provision contained therein either generally or in so far as it affects any property of the applicant, and may, if satisfied that the authorisation granted by the Order is not empowered to be granted or that the interests of the applicant have been substantially prejudiced by any requirement of the said Schedule or of any regulation made thereunder not having been complied with, quash the Order or any provision contained therein either generally or in so far as it affects any property of the applicant.
