Reference to the National Board for Prices and Incomes

#### RENTAL CHARGES FOR EQUIPMENT HIRED FROM IBM UK LIMITED

REPRESENTATIONS have recently been made to the Ministry of Technology by companies renting data-processing installations from IBM UK LIMITED about the increased rental charges to cover increases in costs, attributed among other things, to devaluation, which have been announced to take effect from 1st April 1968. The First Secretary of State and Secretary of State for Employment and Productivity and the Minister of Technology consider that the justification for the increases in these charges should be independently examined by the National Board for Prices and Incomes.

Accordingly, in pursuance of their powers under Section 2(1) of the Prices and Incomes Act 1966, the First Secretary of State and Secretary of State for Employment and Productivity and the Minister of Technology hereby refer to the National Board for Prices and Incomes for examination the question of the increased rental charges notified by IBM UK Limited. and 1951 and Alkali Works (Scotland) Order, 1965

## STOPPING UP OF HIGHWAYS IN THE CITY OF EDINBURGH

# TRUNK ROADS A.85 and A.816 IN OBAN




