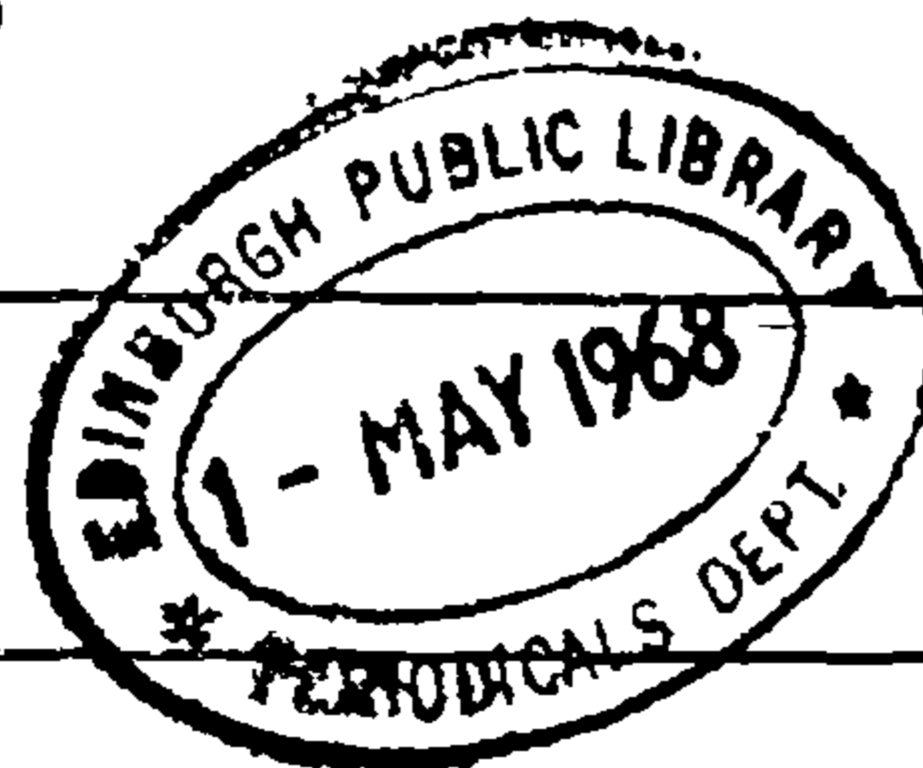

### TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday the 3rd May 1968, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, and the National Loans Act, 1968, to the amount of £140,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000 or £250,000. They will be dated at the option of the tenderer on any business day from Monday the 6th May 1968, to Saturday the 11th May 1968, inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being a multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent on the the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. (Saturday 11 a.m.) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

## REPORT OF THE NATIONAL BOARD FOR PRICES AND INCOMES

### INCREASES IN RENT OF LOCAL AUTHORITY HOUSING

ON 12th December 1967, in pursuance of their powers under section 2(1) of the Prices and Incomes Act 1966, the Secretary of State for Economic Affairs, the Minister of Housing and Local Government, the Secretary of State for Scotland and the Secretary of State for Wales, referred for examination to the National Board for Prices and Incomes the reasons for, and phasing of, increases in rents of local authority housing, with particular reference to the increases in rents by the authorities named in the schedule to the reference and to any proposed rent increase affecting tenants of the Greater London Council.

The Board has now made its report, entitled "Increases in Rents of Local Authority Housing." In accordance with section 5(1) of the Prices and Incomes Act 1966, the First Secretary of State for Employment and Productivity, the Minister of Housing and Local Government, the Secretary of State for Scotland and the Secretary of State for Wales hereby give notice that the report was first published as Command Paper Number 3604 on 25th April 1968.

## REPORT OF THE NATIONAL BOARD FOR PRICES AND INCOMES

### PAY OF MUNICIPAL BUSMEN

ON 26th January 1968 in pursuance of their powers under section 2(1) of the Prices and Incomes Act, 1966, the Secretary of State for Economic Affairs and the Ministers of Labour and Transport referred for examination to the National Board for Prices and Incomes (a) the agreement of 14th December 1967, which provided for an increase in pay for all adult employees in the municipal bus industry, and (b) the award made on 22nd January 1968, by the Nottingham City Council to implement the above agreement from 4th February 1968.

The Board has now made its report entitled "Pay of Municipal Busmen." In accordance with section 5(1) of the Prices and Incomes Act, 1966, the First Secretary of State and Secretary of State for Employment and Productivity and Minister of Labour, and Minister of Transport hereby give notice that the report was first published as Command Paper Number 3605 on 26th April 1968.

### HERRING INDUSTRY SCHEME 1951

#### NOTICE OF RULE

THE Herring Industry Board hereby give notice that they have this day made a Rule by virtue of the powers vested in them by the Herring Industry Scheme 1951, having the effect of establishing between the Twenty-ninth day of April 1968, and the Third day of May 1969:

- upset or minimum prices on first sales of herring by auction at various places for various uses;

BURGH OF BONNYRIGG AND LASSWADE

*(Various Streets) (Prohibition of Waiting) Order 1968*

Save as provided in Paragraph 2 of this schedule, no person shall except upon the direction and with the permission of a Police Constable in uniform, cause or permit any vehicle to wait at any time between the hours of 9 a.m. and 6 p.m. on Mondays to Saturdays (both days inclusive) in any of the lengths of road specified in the annexation hereto, other than so long as may be necessary:

- (a) to enable a person to board or alight from the vehicle ;
- (b) to enable goods to be loaded on to or unloaded from the vehicle ;
- (c) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the lengths of road so referred to, or the laying, erection, alteration or repair in or near to hand of the said lengths of road, of any sewer, sewer main pipe or apparatus for the supply of water, gas or electricity, or of any telegraphic line as defined in the Telegraphic Act 1878 ; or
- (d) to enable the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to any of the said lengths of road.

2. Nothing in Paragraph 1 of this schedule shall prevent any person from causing or permitting a vehicle to wait in—

- (a) the lay-by *ex adverso* 6 to 22 High Street, Bonnyrigg ;
- (b) the lay-by *ex adverso* 2 to 6 Campview Road, Bonnyrigg ; or
- (c) the lay-by *ex adverso* 4 to 14 Polton Street, Bonnyrigg,

provided that no vehicle shall so wait for a longer period than thirty minutes outside the same premises.

*Annexation*

1. On the west side of High Street, Bonnyrigg, (Route B.704), from its junction with Polton Street (Route B.6094) northwards to its junction with Park Road, Bonnyrigg, for 231 yards and from its junction with Park Road northwards to the goods entrance to Messrs. Henry Widnell and Stewart's Factory for 131 yards.

2. On the east side of High Street, Bonnyrigg, (Route B.704), from its junction with Lothian Street (Route A.6094) northwards for 63 yards.
