THE Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under Sections 1, 2 and 13 of the Import Duties Act 1958.

Viz.: The Import Duties (General) (No. 6) Order, 1968.

This Order gives effect to an United Kingdom undertaking to implement in full on 15th July, instead of by stages, certain of the Kennedy Round tariff reductions of particular interest to less developed countries.

The tariff headings covered by the undertaking are shown in the Schedule to the Order and to these has been added heading 21.01(A) (unmixed chicory). This is necessary to preserve for practical reasons, the existing, and intended final Kennedy, alignment between the full and commonwealth preference rates of this heading and those of heading 09.01(C) (mixtures of coffee and chicory) which is among the items of particular interest to less developed countries covered by the Schedule.

The Order comes into operation on 15th July 1968, and has been published as Statutory Instrument 1968 No. 1030.

## PRICES AND INCOMES ACTS 1966 to 1968

Notice under section 3(4) (a) of the Prices and Incomes Act 1968 of a proposal to make a further Order to amend an Order made under section 1(2) (b) of the Prices and Incomes Act 1967 so as to extend a standstill under section 15(2) of the Prices and Incomes Act 1966 on the implementation of part of an agreement and of an award relating to terms and conditions of employment in the road passenger transport industry.

THE Secretary of State hereby gives notice of a proposal to make an Order under section 3(4) of the Prices and Incomes Act 1968 in the terms set out at the end of this notice. The effect of this Order will be to extend until 26th December 1968 the standstill on the implementation of clause 1 of the undermentioned agreement and of the undermentioned award which standstill was applied by virtue of section 15(2) of the Prices and Incomes Act 1966 in consequence of a reference to the National Board for Prices and Incomes under section 2 of that Act made on 27th January 1968 and a direction under section 15(1) of that Act, and was continued by virtue of an Order made by the Secretary of State on 20th May 1968 under section 1(2) (b) of the Prices and Incomes Act 1967. The said agreement and award are respectively:

- (a) the agreement providing for increases with effect from the first full pay period following 14th December 1967 in the rates of pay of all adult employees in the road passenger transport industry previously covered by the National Joint Industrial Council for the road passenger transport industry, made on 14th December 1967 between the Federation of Municipal Passenger Transport Employers on the one hand and the Transport and General Workers' Union and the National Union of General and Municipal Workers on the other, and ratified by the National Joint Industrial Council for the road passenger transport industry on 11th January 1968; and
- (b) the award made on 22nd January 1968 whereby the Nottingham City Council by its Transport Committee

resolved to implement the terms of the said agreement referred to in paragraph (a) above with effect from the pay week beginning on 4th February 1968.

Representations about the proposal may be made by or on behalf of employers or employees affected by the said agreement or award, or by or on behalf of any employer's organisation, trade union or trade union organisation directly or indirectly representing employers or employees so affected, to the Secretary of State in writing addressed to the Department of Employment and Productivity, 8 St. James's Square, London S.W.1, not later than 25th July 1968.

After that date, and subject to the consideration of any representations duly made, the proposed Order may be made in the following terms:

- (1) This Order, which may be cited as the Awards and Settlements (Temporary Continuation of Standstill) (No. 1) (Amendment) Order 1968, shall come into operation on 26th July 1968.
  - (2) The Interpretation Act 1889 (1889 c. 63) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
2. The Awards and Settlements (Temporary Continuation of Standstill) (No. 1) Order 1968 (S.I. 1968 No. 816) shall have effect as if in Article 2 thereof for '26th July 1968' there were substituted '26th December 1968.'

## THE EDINBURGH-GLASGOW TRUNK ROAD

*Drumpark, Shawhead and Newhouse Industrial Estate Junctions Slip Roads Trunking Order*

## HARBOURS ACT 1964

## THE DUNDEE HARBOUR REVISION ORDER 1968

NOTICE Is Hereby Given, That the Dundee Harbour Trustees (hereinafter called "the Trustees") have applied to the Minister of Transport to make a Harbour Revision Order under section 14 of the Harbours Act 1964.

The objects of the proposed Order are:

- (a) To reconstitute the Dundee Harbour Trust; to provide that the Trust shall consist of fourteen members of whom one shall be the Lord Provost of the City of Dundee for the time being and thirteen shall be appointed to specify the bodies who are to appoint the appointed Trustees; to provide for the qualification of Trustees and their appointment.
- (b) To redefine the limits of the area over which the Trustees exercise jurisdiction.
- (c) To make provision with respect to the fixing and alteration of the financial year of the Trustees; to extend and amend the financial powers of the Trustees, including their powers of borrowing and their powers to make contributions to funds for the benefit of staff, and to amend provisions in relation to sinking funds; to amend the Dundee Harbour and Tay Ferries Order 1952 by substituting in Schedule C a new form of mortgage.
- (d) To empower the Trustees to provide benefits for or in respect of the welfare of persons employed or formerly employed by them, including pensions and comparable benefits, and to discontinue the superannuation fund established under the Dundee Harbour and Tay Ferries (Superannuation) Order 1939 when not less favourable alternative benefits are provided.
- (e) To extend and amend the powers of the Trustees to make byelaws and to provide as to the confirmation of byelaws made by the Trustees.
- (f) To enable the Trustees when hiring out vessels and equipment, to hire out operators thereof.
- (g) To amend provisions of the Dundee Harbour and Tay Ferries Order 1952 and to repeal other provisions of that Order.

  - Funeral undertaking.
  - Loading, unloading, collection or delivery of goods, subject to a maximum waiting period of 30 minutes at any one place.
  - The removal of furniture.
- (5) This Order shall not apply to severely disabled drivers holding a current certificate of exemption from the Town Council.
- (6) The restriction imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made under the Road Traffic Act 1930 to 1960 or by or under any other enactment.
