TENDERS FOR TREASURY BILLS

(being a multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- 5. Tenders must be made through a London Banker, Discount House or Broker.

Notification will be sent, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. (Saturday 11 a.m.) on the day on which the relative Bills are to be dated.

PRICES AND INCOMES ACT 1966

Reference to the National Board for Prices and Incomes
PAY AND DUTIES OF LIGHT-KEEPERS

THE pay and conditions of light-keepers employed by Trinity House and the Northern Lighthouse Board are subject to an agreement between the Lighthouse Authorities and the Transport and General Workers' Union. There is no part of light-keepers pay which has been separately identified as a payment in respect of long hours of duty. A claim originally made in November 1967 for a 40 hour week with all hours in excess of 40 paid at overtime rates is being pursued by the Transport and General Workers' Union.

In pursuance of their powers under Section 2(1) of the Prices and Incomes Act 1966 the First Secretary of State and Secretary of State for Employment and Productivity and the Board of Trade hereby refer to the National Board for Prices and Incomes for examination the question of pay and duties of light-keepers employed by Trinity House and the Northern Lighthouse Board with particular relation to hours worked.

CLEAN AIR ACT, 1956 THE BURGH OF DUMBARTON Smoke Control Area Order No. 9, 1969

- 1. NOTICE is hereby given that the Town Council of Dumbarton in exercise of the powers conferred on them by Section 11 of the above mentioned Act on the Twenty-sixth day of February 1969 made an Order entitled "The Burgh of Dumbarton Smoke Control Area Order, No. 9, 1969" declaring the area described in the Schedule hereto to be a Smoke Control Area, which Order is about to be submitted to the Secretary of State for confirmation.

Subject to the exemptions provided by virtue of Section 11(4) of the Act if on any day after the Order has come into operation smoke is emitted from a chimney of any building within the Smoke Control Area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £20 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels are anthracite and semi-anthracite, briquetted fuels carbonised in the process of manufacture, coke, electricity, gas, low temperature carbonisation fuels and low volatile steam coals.
- 3. Copies of the Order and of the map referred to therein may be inspected free of charge at the Town Clerk's Office, Municipal Buildings, Dumbarton, at all reasonable times during the period of six weeks from the Tenth day of March 1969.

- (1) Castle Street: the east side of the road from a point 75 feet north of its junction with Queen Street to a point 45 feet north of its junction with Canmore Street.
- (2) East High Street: (1) the north side of the road from its junction with the Cross to a point 443 feet east of said junction.
