#### TENDERS FOR TREASURY BILLS

1. Reference to the National Board for Prices and Incomes

PRICES OF NON-ALLOY BRIGHT STEEL BARS

A PRIVATE producer of non-alloy bright steel bars has made a proposal to the Minister of Power for an increase in the prices of this product. The Minister considered that other producers may also wish to increase their prices. There is a close relationship between the prices of non-alloy bright steel bars and the prices of some of the products included in the proposals of the British Steel Corporation which are already being examined by the National Board for Prices and Incomes.

Accordingly, in pursuance of their powers under section 2(1) of the Prices and Incomes Act 1966, the First Secretary of State and Secretary of State for Employment and Productivity, and the Minister of Power, hereby refer to the National Board for Prices and Incomes the question of the prices of non-alloy bright steel bars, taking into account the proposals made to the Minister which are the subject of the Board's enquiry into steel prices generally in accordance with terms of reference published in the Gazette on 24th December 1968.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being a multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker. Discount House or Broker.

6. Notification will be sent, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment ip full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. (Saturday 11 a.m.) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.





FRANCE: OFFICIAL CERTIFICATE

THE Secretary of State for Scotland gives notice that in exercise of the powers conferred on him by the Imported Food (Scotland) Regulations 1968, he hereby recognises, subject to the conditions hereinafter set out, each of the Official Certificates, of which particulars are given in the First Schedule hereto as showing:

- (a) that the meat to which they relate or the meat from which the meat product to which they relate was prepared, was derived from mammals inspected before and after death in the country of origin of the meat and passed in accordance with criteria satisfactory to the Secretary; and
- (b) that the dressing, packing and other preparation of the meat or meat product was carried out with all necessary precautions for the prevention of danger to health.

Where the Certificate is in the form of a label the recognition will apply only if the label is securely affixed to the meat or the package containing the meat or meat product and if the label has not in any other circumstances or on any other occasion been used as an Official Certificate; and where the Certificate is in the form of a stamp, the recognition will apply only if the stamp is clearly impressed or otherwise marked on the meat or the package containing the meat or meat product.


Recognition of the Official Certificates is extended to include meat described in the Second Schedule hereto.

The Official Certificate reproduced in the Schedule to the Notice published in the Edinburgh Gazette dated 5th April 1938 will continue to be recognised for the importation of meat products (including canned meat, edible fats and casings) until 31st March 1969, from which date it is hereby revoked.
