Reference to the National Board for Prices and Incomes of the pay settlement reached on 1st December 1968 between the Newspaper Publishers' Association and the National Union of Journalists.

THE First Secretary of State and Secretary of State for Employment and Productivity, acting in pursuance of her powers under section 2(1) of the Prices and Incomes Act 1966, hereby refers to the National Board for Prices and Incomes for their examination and report the pay settlement reached on 1st December 1968 between the Newspaper Publishers' Association and the National Union of Journalists and the settlement's repercussions on the pay of all journalists employed by the newspapers covered by the settlement and its relationship to pay negotiations for other groups of journalists.
