TENDERS FOR TREASURY BILLS

- 1. The Lords Commissioners of Her Majesty's Treasury nereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday the 21st March 1969, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, and the National Loans Act, 1968, to the amount of £120,000,000.
- 2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000 or £250,000. They will be dated at the option of the tenderer on any business day from Monday, the 24th March 1969, to Saturday, the 29th March 1969, inclusive, and will be due 91 days after date.
- 3. The Bills will be issued and paid at the Bank of England.
- 4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being a multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- 5. Tenders must be made through a London Banker, Discount House or Broker.
- 6. Notification will be sent, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. (Saturday 11 a.m.) on the day on which the relative Bills are to be dated.
- 7. Members of the House of Commons are not precluded from tendering for these Bills.

- 8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
- 9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

PRICES AND INCOMES ACT, 1966

Reference to the National Board for Prices and Incomes of a settlement and certain proposals relating to the pay of workers employed in the exhibition industry and notice of a direction under section 15 of the Prices and Incomes Act 1966 in relation to the settlement

THE First Secretary of State and Secretary of State for Employment and Productivity (herinafter referred to as "the Secretary of State"), acting in pursuance of her powers under section 2(1) of the Prices and Incomes Act 1966, hereby refers to the National Board for Prices and Incomes for their examination and report:

- (1) the settlement reached on 7th February 1969 by the National Joint Council for the Exhibition Industry providing, amongst other things, for—
 - (a) increases in the hourly rates of wages of cratsmen and labourers of fourpence and threepence respectively; and
 - (b) a productivity bonus of ten shillings per day (including week end working) for all operatives covered by the said National Joint Council employed in shops and exhibition halls; and
- (2) the proposals made on 28th February by the employers' side to the operatives' side of the National Exhibition Electrical Joint Industrial Council offering amongst other things—
 - (a) increases in the hourly rates of wages of journeymen electrictians and adult mates of fivepence and fourpence respectively; and
 - (b) a productivity bonus of ten shillings per day (including week end working) for all operatives covered by the said Joint Industrial Council employed in shops and exhibition halls.

By virtue of the aforesaid reference the Secretary of State, acting in pursuance of her powers under section 15(1) of the Prices and Incomes Act 1966, hereby directs that the said section 15 shall apply to the settlement specified in paragraph (1) above.

Note: --

This reference and direction take effect on the date of this issue of the Gazette. The direction that section 15 of the Prices and Incomes Act 1966 shall apply results in a stand-still on the implementation of the settlement referred to in the direction until the publication (not later than 3 months from the said date) of the Board's report on the reference.

It should be noted that, by virtue of section 1 of the Prices and Incomes Act 1967, as extended by section 3 of the Prices and Incomes Act 1968, the standstill may continue beyond publication of the Board's report if it should contain a recommendation adverse in any respect to the implementation of the said settlement.

SPECIAL ROADS ACT, 1949

(Sheil Bridge-Inverinate Diversion Side Roads)

THE Secretary of State gives notice that he has made an Order under section 14 of the Special Roads Act 1949 to provide for the construction of two new lengths of road and the improvement of two lengths of existing road in the County of Ross and Cromarty to form junctions with the Shiel Bridge-Inverinate Diversion on the Invergarry-Kyle of Lochalsh Trunk Road (A.87) and the stopping up of two lengths of the superseded trunk road when the lengths of new road and the Shiel Bridge-Inverinate Diversion are open to through traffic.

TRUNK ROADS ACT, 1946

Shiel Bridge-Inverinate Diversion

THE Secretary of State gives notice that he has made an Order under section 1 of the Trunk Roads Act, 1946, as read with the Transfer of Functions (Roads, Bridges and Ferries) Order, 1955, the effect of which will be that the Diversion which he proposes to construct across the tidal waters of Loch Duich in the County of Ross and Cromarty from a point near Kintail Lodge Hotel to a point north-east of the Old Manse at Inverinate will become a trunk road on 23rd March, 1969; and that length of the existing Invergarry-Kyle of Lochalsh Trunk Road to be superseded thereby around the head of Loch Duich will cease to be a trunk road on 16th May next after the date on which notice is given by the Secretary of State to Ross and Cromarty County Council (who will thereafter become the highway authority responsible for that length) that the said diversion is open for through traffic.
