NOTICE Is Hereby Given that the County Council of Stirling propose to make an Order under sections 1 and 2 of the Road Traffic Regulation Act, 1967, to prohibit vehicles on the lengths of road specified in the Schedule hereto.

The Order will provide for exceptions to enable a vehicle to wait if it is being used in connection with building operations, demolitions, road maintenance, cleansing, postal, fire brigade, ambulance or police purposes.

Objections to the proposals must be sent in writing to the Undersigned not later than twenty one days from the date hereof.

<i>Road at Balfroon in the Parish of Balfroon and County of Stirling.</i>	<i>Side and section of road on which waiting is prohibited at any time.</i>
1. Dumgoyne - Kepulloch Road A.875 (known as Buchanan Street).	On both sides thereof from a point two hundred and fifty feet North of its junction with Cotton Street (Unclassified) Southwards to a point two hundred and fifty feet South of said junction.
2. Cotton Street (Unclassified).	On the South side thereof from its junction with Dumgoyne-Kepulloch Road A.875 Eastwards for a distance of two hundred feet.

<i>Road at Milton of Campsie in the Parish of Campsie and County of Stirling.</i>	<i>Side and section of road on which waiting is prohibited at any time.</i>
1. Kilsyth-Strathblane Road A.891	(a) On the North side thereof from a point thirty-five yards West of its junction with School Lane (Unclassified) Eastwards to a point twenty-five yards East of its junction with Scott Avenue (Unclassified) (b) On the South side thereof from a point forty yards West of its junction with Birdston Road B.757 Eastwards to a point twenty-five yards East of its junction with Scott Avenue, (Unclassified).
2. Birdston Road B.757	On both sides thereof from its junction with Kilsyth-Strathblane Road A.891 Southwards for a distance of forty yards.
3. School Lane (Unclassified)	(a) On the North side thereof from its junction with Kilsyth-Strathblane Road A.891 North-eastwards for a distance of forty-five yards. (b) On the South side thereof from its junction with Kilsyth-Strathblane Road A.891 North-eastwards to its junction with Craighead Road (Unclassified).
