TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday, the 11th April 1969, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, and the National Loans Act, 1968, to the amount of £130,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000 or £250,000. They will be dated at the option of the tenderer on any business day from Monday the 14th April 1969, to Friday, the 18th April 1969, inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being a multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. (Saturday 11 a.m.) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

2. Revoke the Corporation of Glasgow (Traffic Regulation) (Dumbarton Road) Order, 1967 to the effect of removing the prohibition on vehicles entering the undernoted roads from Dumbarton Road except those requiring access to premises in the roads, viz.:

Haldane Street, Victoria Park Street, Elm Street, Lime Street.

3. Introduce new restrictions on waiting by vehicles between the hours of 8 a.m. and 6.30 p.m. from Mondays to Fridays inclusive and between the hours of 8 a.m. and 1 p.m. on Saturdays and a ban on loading and unloading of goods between the hours of 8.15 a.m. and 9.15 a.m. from Mondays to Saturdays inclusive and between the hours of 4.15 p.m. and 6.30 p.m. from Mondays to Fridays inclusive on the following lengths of roads, viz.:

DUMBARTON ROAD

(from the west kerbline of Broomhill Avenue eastwards

to a point 140 feet west of the west kerbline of Broomhill Drive); and

(from a point 140 feet east of the east kerbline of Broomhill Drive eastwards to the west kerbline of Sorley Street)

DUMBARTON ROAD

(from the west kerbline of Squire Street westwards for 140 feet)

SAWMILL ROAD

(from 140 feet south of the south kerbline of Dumbarton Road southwards to the north kerbline of South Street)

SMITH STREET

(from the south kerbline of Dumbarton Road to the north kerbline of South Street)

SOUTH STREET

(from the west kerbline of Sawmill Road to the east kerbline of Squire Street)

SQUIRE STREET

(from the south kerbline of Dumbarton Road to the north kerbline of South Street).

4. Prohibit stopping by vehicles at any time (subject to certain exceptions) on the following lengths of roads, viz.:

(a) that length of the west and east carriageways of Route A.739 from its junction with Benryknowes Road (Route A.739) at the commencement of the overbridge in a northerly direction by way of the Clyde Tunnel, the Clyde Tunnel North approach road and Balshagray Avenue to its junction with Crow Road;

(b) that length of the north and south carriageways of the Clydeside Expressway (Route A.814) from its junction with Dumbarton Road (Route A.814) at the projection of the east kerbline of Lennox Avenue to its junction with Dumbarton Road (Route A.814) at the projection of the west kerbline of Broomhill Avenue; and

(c) all connecting roads forming the junction of the Clydeside Expressway (Route A.814) with the Clyde Tunnel North approach roads (Route A.739) and contained within the interchange.
