

## PAY OF GROUND STAFF AT AERODROMES

CIVIL publicly-owned aerodromes in the United Kingdom are at present operated either by the British Airports Authority, local authorities, or the Board of Trade. The pay structures devised by these operating authorities for the ground staffs they employ on airport industrial duties differ widely and this has led to difficulties at some aerodromes.

Amendment of Waiting Restrictions

#### TRUNK ROAD (ROUTE A.68) IN JEDBURGH

THE Secretary of State gives notice that he has made an Order under Sections 1 and 3 of the Road Traffic Regulation Act 1967, the effect of which is set out in the Schedule below.

#### SCHEDULE

The effect of the Order is to amend the Trunk Roads (High Street, Jedburgh) (Unilateral Waiting) Order 1967, which imposes unilateral restrictions on waiting and loading in High Street (Trunk Road A.68) between the hours of 9.30 a.m. and 6 p.m. Mondays to Saturdays inclusive, by prohibiting waiting and loading at any time on the following lengths of trunk road:

- (a) On both sides of High Street from Queen Street southwards for 30 yards;
- (b) On the west side of High Street from Exchange Street northwards for 30 yards; and
- (c) On the east side of High Street from Cannongate northwards for 24 yards.

The exceptions to the existing Order enabling a vehicle to wait for as long as necessary for a person to board or alight, to enable a vehicle to take in petrol, etc., from any garage and to be used in connection with maintenance operations and other works, are not affected. #### SCHEDULE

Waiting restrictions would be imposed between the hours of 8 a.m. and 6 p.m. Mondays to Saturdays inclusive on lengths of the Trunk Road (Route A.73) in Carluke as follows:

Any person entitled to claim compensation in respect of any of the land to which the Sixth Schedule applies or in respect of any interest in any such land, may send to the Corporation of the City of Glasgow his name and postal address, a description of the land in which he has an interest sufficient to enable them to identify the extent and boundaries thereof, and particulars of his interest in the land, of any leases and tenancy of, and any heritable securities and other real burdens and encumbrances affecting the land, and of any war damage sustained by the land.

Provision as to entry on and vesting of the land is contained in Sub-paragraph (4) of Paragraph 3 of the Sixth Schedule. The general effect of this provision is set out below but reference should be made to the Sixth Schedule itself for its precise operation:

The earliest date at which such a declaration may be executed is the expiration of a period of fourteen days from the date of the recording of the Order in the Register of Sasines.
- On the recording of a Notice of Title in the appropri-(n) ate Register of Sasines the said land shall vest in the said The Corporation of the City of Glasgow.

THE Town Council of the Burgh of Blairgowrie and Rat propose to make an Experimental Traffic Order under Section 9 of the Road Traffic Regulation Act 1967, the effect of which is as set out in the Schedule hereto.

(iii) The said The Corporation of the City of Glasgow will be liable to pay the like compensation and interest as would have been payable if the provisions of the 1845 Act had been complied with.

There are exceptions from the position as indicated above in the case of short tenancies and long tenancies about to expire.

The Order as confirmed becomes operative on the Eleventh day of April 1969, but if application is made to the Court of Session under Paragraph 15 of the First Schedule to the Acquisition of Land (Authorisation Procedure) (Scotland) Act, 1947, within a period of six weeks from that date by any person aggrieved by the Order who desires to question the validity thereof, the Court of Session may, by interim order, suspend the operation of the Order of any provision contained therein either generally or in so far as it affects any property of the applicant, and may, if satisfied that the authorisation granted by the Order is not empowered to be granted or that the interests of the applicant have been substantially prejudiced by any requirement of the said Schedule or of any regulation made thereunder not having been complied with, quash the Order or any provision contained therein either generally or in so far as it affects any property of the applicant.
