WAGES COUNCILS ACT 1959

HOLLOW-WARE WAGES COUNCILS (GREAT BRITAIN)

THE Hollow-Ware Wages Council (Great Britain) hereby gives notice of its intention to submit to the Secretary of State for Employment and Productivity proposals for (1) increasing the statutory minimum remuneration set out in the Wages Regulation (Hollow-Ware) Order 1968 (Order H.(96)); (2) amending the provisions relating to holidays and holiday remuneration set out in the Wages Regulation (Hollow-Ware) (Holidays) Order 1966 (Order H.(92)) as amended by the Wages Regulation (Hollow-Ware) Order 1968 (Order H.(96)); and (3) the revocation of Order H.(96) and Order H.(92).

WAITING RESTRICTIONS ON A.77 IN MAYBOLE

5. To permit the loading and unloading of vehicles for 20 minutes in any hour, Monday to Saturday, 8 a.m. to 6.30 p.m. on the north-east side of St. Clair Street for a distance of approximately 16 yards northwards from the limit of the proposed waiting and loading and unloading restriction.

COUNTY COUNCIL OF ROSS & CROMARTY

Civic Amenities Act 1967

THE County Council of Ross and Cromarty have agreed to designate the area within the Burgh of Cromarty bounded by Forsyth Place, Shore Street, Burnside Place and Church Street as a "Conservation Area" under Section 1(1) of the above Act, and comprising mainly the area known as "Fishertown." BURGH OF HAMILTON
