TENDERS FOR TREASURY BILLS

- 1. Notification will be sent, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.
- 7. Members of the House of Commons are not precluded from tendering for these Bills.
- 8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

BURGH OF CLYDEBANK CLEAN AIR ACTS 1956 and 1968

The North and South Drumry Smoke Control Area Order No. 7, 1969

- (1) NOTICE Is Hereby Given that the Town Council of the Burgh of Clydebank in exercise of the powers conferred on them by Section 11 of the Clean Air Act, 1956, on the Fourth day of July 1969, made an Order entitled "The North and South Drumry Smoke Control Area Order No. 7, 1969," declaring the area described in the Schedule hereto to be a Smoke Control Area, which Order is about to be submitted to the Secretary of State for Scotland for confirmation.
- (2) Subject to any exemptions provided by virtue of Section 11(4) of the Act, if, on any date after the Order has come into operation, smoke is emitted from a chimney of any building within the Smoke Control Area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £20 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. Authorised fuels are: Anthracite and semi-anthracite, briquetted fuels carbonised in the process of manufacture, coke, electricity, gas, low temperature carbonisation fuels and low volatile steam coals.
- (3) Copies of the Order and of the Map referred to therein may be inspected free of charge at the Town Clerk's Office, Municipal Buildings, Clydebank, between 8.35 a.m. and 5 p.m. Monday to Friday during the period of six weeks from the Eighteenth day of July 1969.
