### TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday, the 28th November 1969, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, and the National Loans Act, 1968, to the amount of £100,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000 or £250,000. They will be dated at the option of the tenderer on any business day from Monday, the 1st December 1969, to Friday, the 5th November 1969, inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being a multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

## PRICES AND INCOMES ACT 1966

### SALARY STRUCTURES

ON 25th July 1968, in pursuance of her powers under Section 2(1) of the Prices and Incomes Act 1966, the First Secretary of State and Secretary of State for Employment and Productivity referred to the National Board for Prices and Incomes for examination the question of the principles which should govern the development in industry and commerce of salary structures for managerial, executive, professional and technical staff. The Board has now made its report entitled "Salary Structures." In accordance with section 5(1) of the Prices and Incomes Act 1966, the First Secretary of State and Secretary of State for Employment and Productivity hereby gives notice that the report was first published as command paper number 4178 on Tuesday, 18th November 1969.

### THE KINROSS AND MILNATHORT BYPASS SPECIAL ROAD

THE Secretary of State has made the following Scheme and Orders:

1. A Scheme for twelve lengths of special road (motorway) to connect at four grade-separated junctions, the Kinross and Milnathort Bypass Special Road with the realigned Crook of Devon-Bogside Road (B.9097) at Gairney Bridge, the Kincardine-Kinross Trunk Road (A.977), at Kinross Junction, the Stirling-Milnathort Road (A.91) at Hilton and the Milnathort-St. Andrews Trunk Road (A.91) at Arlary. The Scheme also provides that the special roads shall be trunk roads and that they will be for use only by motorway classes of traffic.

2. An Order for a new length of trunk road to connect the Milnathort-St. Andrews Trunk Road (A.91) to the Inverkeithing-Perth Trunk Road (A.90) at Southfield in Kinross-shire.
