**PRICES AND INCOMES ACT 1966**

*Reference to the National Board for Prices and Incomes*

**COSTS AND PRICES IN THE GAS INDUSTRY**

ON 12th January 1970 the National Joint Industrial Council for the Gas Industry reached an agreement providing for a flat rate increase in pay of 1s. 0½d. per hour with effect from 18th January 1970. The Workers' Side of the Council gave an undertaking that they would continue to encourage co-operation in measures designed to achieve maximum efficiency of operations. The Government consider that any additional costs resulting from the agreement must be absorbed by higher productivity and not passed on to the consumer.

In pursuance of their powers under Section 2(1) of the Prices and Incomes Act 1966, the First Secretary of State and Secretary for Employment and Productivity and the Minister of Technology hereby refer to the National Board for Prices and Incomes for examination and report the effect of this agreement on costs and the steps to be taken by the Gas Industry to absorb these costs without price increases by higher productivity and increased efficiency generally while achieving the industry's financial objective.

**PRICES AND INCOMES ACT 1966**

**PAY AND OTHER TERMS AND CONDITIONS OF EMPLOYMENT OF WORKERS IN THE POTTERY INDUSTRY**

*Direction under Section 5(4) extending the period within which the National Board for Prices and Incomes must publish their report*

1. WHEREAS the First Secretary of State and Secretary of State for Employment and Productivity, in pursuance of her powers under Section 2(1) of the Prices and Incomes Act 1966, referred the above-mentioned question to the National Board for Prices and Incomes for examination and has published the text of the reference in the Gazette on 24th October 1969;

2. And whereas by Section 5(3) of the Act, but subject to Section 5(4), the Board are required to make their report so as to allow publication within three months of the said date;

3. Now therefore, the First Secretary of State and Secretary of State for Employment and Productivity, in pursuance of her powers under the said Section 5(4), hereby directs that the said period of three months be extended by three months.

## TRUNK ROADS ACT 1946

## GLASGOW-GREENOCK TRUNK ROAD (A.8)

THE Secretary of State has made the Glasgow-Greenock-Monkton Trunk Road (Langbank and other Diversions) Order, 1969, whereby two diversions of the said trunk road will be built, one at Langbank and the other West of Langbank. The Order also provides that when the new road at Langbank is open to traffic, the existing road through the village shall cease to be a trunk road.

This order modifies the draft proposals published in January 1969, by excluding a proposed diversion at West Ferry which has been superseded by draft proposals relating to Bishopton Bypass Stage II Special Road which are now published.

Any person aggrieved by the order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the statutory powers or on the ground that any requirement of the said Act of 1946 has not been complied with in relation to the order may, within 6 weeks of 20th January 1970 apply to the Court of Session for the suspension or quashing of the order or of any provision contained therein.

## SPECIAL ROADS ACT 1949

## THE BISHOPTON BYPASS (STAGE II) SPECIAL ROAD

THE Secretary of State gives notice that he proposes to make the following schemes and order:

1. A scheme for a special road (motorway) commencing from the western end of the Bishopton Bypass (Stage I) Special Road, near the junction of Old Greenock Road (C.22) and Drumcross Road in the County of Renfrew, and extending generally westwards for 3 miles to West Ferry. The draft scheme also provides for the special road to become a trunk road and it will be for use only by motorway classes of traffic.

2. A scheme for two special roads (connecting roads) which will form part of a junction at West Ferry to connect the proposed Bishopton Bypass (Stage II) Special Road (which is referred to in paragraph 1 above) with the all-purpose trunk road to the west (which it is proposed to widen to dual carriageway standard) and with the existing trunk road through Bishopton. The draft scheme also provides for the two connecting roads to become trunk roads for use only by motorway classes of traffic.

3. An order for altering or stopping up roads, constructing new roads, stopping up private means of access and providing new means of access, all on or near the route of the Bishopton Bypass (Stage II) Special Road. The County Council of Renfrew will become the highway authority for the new roads, except for the proposed junction at West Ferry which will become a trunk road.

Copies of the draft schemes and order, with plans, and a statement explaining the proposals, may be inspected free of charge at all reasonable hours at the office of the Scottish Development Department, 43 Jeffrey Street, Edinburgh EH1 1DL, and at the office of Renfrew County Council, County Buildings, Paisley, and Renfrew Third District Council, District Council Office, Bishopton.
