TENDERS FOR TREASURY BILLS

1. 6. Notification will be sent, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the

amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.
8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

STOPPING UP OF HIGHWAYS IN THE CITY OF EDINBURGH

THE TRUNK ROADS (ST. ANDREWS) (PROHIBITION OF WAITING) ORDER 1970

THE Secretary of State proposes to make an order to prohibit waiting at any time on lengths of the trunk road (Route A918) Pilmour Links, North Street and South Street, St. Andrews.

Exceptions would permit waiting on the proposed restricted lengths of road for the purpose of:

- loading and unloading goods

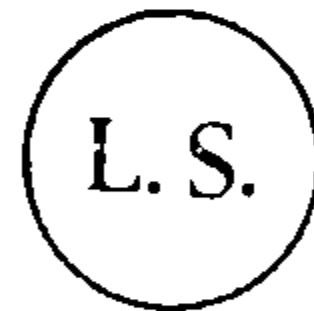

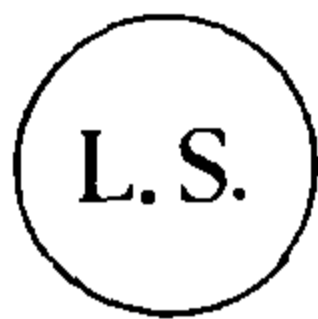

THE USSR: OFFICIAL CERTIFICATE

THE Secretary of State for Scotland gives notice that in exercise of the powers conferred on him by the Imported Food (Scotland) Regulations, 1968 he hereby recognises subject to the conditions hereinafter set out, the Official Certificate of which particulars are given in the First Schedule hereto as showing:

- (a) that the meat from which the meat product to which it relates was prepared, was derived from mammals inspected before and after death in the country of origin of the meat and passed in accordance with criteria satisfactory to the Secretary of State and
- (b) that the dressing, packing and other preparations of the meat product was carried out with all necessary precautions for the prevention of danger to health.

The said Certificate is recognised subject to the following conditions:

- (i) This recognition applies to specified meat products imported from USSR but does not apply to any such meat product derived from mammals killed when wild.
- (ii) The Official Certificate is in the form of a label and the recognition will apply only if the label is securely affixed to the meat product or the package containing the meat product, and if the label has not in any other circumstances or on any other occasion been used as an Official Certificate.
- (iii) Recognition of the Official Certificate is restricted to the extent indicated in the Schedules hereto.
